Referencing Websites and Online Sources in Chicago Author-Date Style

The internet has become an indispensable source of information, and Chicago author-date provides guidelines for citing various online materials.

Websites and Web Pages

For a general webpage, you will typically list the author (if known), the publication date (or most recent update date), the title of the page, the website name, and the URL.
