Understanding the Chicago Manual of Style

The Chicago Manual of Style is a widely respected style guide that provides comprehensive rules for writing, citation, and editing in the United States. It is particularly prevalent in the humanities and social sciences. Two primary citation systems are outlined within CMOS: the notes-bibliography system and the author-date system. Newspaper Article Footnote/Endnote Example

Citing newspaper articles requires the author's name (if provided), the article title in quotation marks, the newspaper title in italics, the full date of publication, and the page number(s). For online newspaper articles, the URL may also be included.

Bibliography Format for Articles
