## Understanding Chicago Citation Examples for Podcasts

The Chicago Manual of Style offers robust guidelines for citing various media, and podcasts are no exception. Its dual-system approach – the author-date system and the notes-bibliography system – allows for flexibility depending on the discipline and publisher's requirements. ## Chicago Style: Notes-Bibliography System for Podcasts

The notes-bibliography system is more common in the humanities. It uses footnotes or endnotes for citations within the text and a bibliography at the end of the paper. Both the note and the bibliography

entry will contain similar information, but the order and punctuation may differ.

## Footnote/Endnote Entry for Podcasts (Notes-Bibliography)

The format for a footnote or endnote citation for a podcast episode typically looks like this:

- First Name Last Name of Host/Producer, "Title of Episode," Title of Podcast, Producer/Network, Release Date, accessed Access Date, URL.

Note that the name is in first name, last name order, and "accessed" along with the access date is often included in the notes-bibliography system, though it's becoming less common if the URL is stable and the content is unlikely to change significantly.

## Bibliography Entry for Podcasts (Notes-Bibliography)

The bibliography entry will closely resemble the footnote but will have a different order and punctuation:

The key difference here is the reversed name order and the period after the URL in the bibliography. This system requires careful attention to commas and periods to ensure accuracy.

Notice how the footnote includes the access date, which is good practice when citing online sources that might be updated or removed. The bibliography entry also includes the access date for completeness.

## Essential Elements of a Podcast Citation

Regardless of which Chicago style system you employ, several key pieces of information are vital for a complete and accurate podcast citation. Understanding these elements will help you construct citations for a wide variety of podcast sources.

### Host(s) or Creator(s)

The primary person or people responsible for creating and hosting the podcast are listed. For the author-date system, this is treated as the author. For the notes-bibliography system, the name order is reversed in the bibliography entry compared to the footnote/endnote.

### Episode Title

The specific title of the episode you are referencing. Episode titles should be enclosed in quotation marks.

## **Podcast Series Title**

The overall name of the podcast series. This is italicized in the notes-bibliography system and is often treated as part of the publisher information in the author-date system.

## **Producer or Network**

The company, organization, or network that produced or distributed the podcast. This helps identify the specific podcast series and its origin.

## **Release Date**

The date the episode was published or released. This is typically the month, day, and year.

## **URL**

The direct web address where the podcast episode can be accessed. If the podcast is available on multiple platforms, choose the most stable or official link, often the one on the podcast's own website.

## **Access Date (for Notes–Bibliography)**

The date you accessed the podcast episode online. This is included in the notes-bibliography system to acknowledge that online content can change.

## **Citing Specific Podcast Scenarios**

While the general formats are straightforward, there are nuances when dealing with different aspects of podcast content or when certain information is missing.

## Citing a Series as a Whole

If you are referencing the podcast series generally, rather than a specific episode, you would cite the series title, producer, and perhaps a range of dates if applicable.

- **Author-Date (Reference List):** Name of Podcast Series. Producer/Network, Year Range or Start Year. URL.
- **Notes-Bibliography (Bibliography):** Name of Podcast Series. Producer/Network. Accessed Month Day, Year. URL.

## Citing Episodes with No Clear Host or Producer

In cases where a podcast lacks a clear host or producer name, you may need to adapt the citation. Often, the podcast series title can be used in place of the author, or you might focus on a different identified creator if available.

## Citing Podcasts with Guests

If a specific guest's contribution is the focus, you may mention them in your introductory text rather than directly in the citation itself. The citation should still reflect the episode's primary creators. However, if you are referencing a specific interview segment, you might need to note that in your

textual analysis.

## In-Text Citations for Podcasts

In-text citations are brief references within your text that direct readers to the full citation in your reference list or bibliography. The format depends on which Chicago system you are using.

### In-Text Citations (Author-Date System)

In the author-date system, the in-text citation typically includes the author's last name and the year of publication. If the episode title is relevant and the author is not explicitly mentioned in the sentence, you might include it.

- (Gladwell 2018)
- (Gladwell, "The Deep End," 2018)

When you mention the author in your text, you only need the date in parentheses:

- Malcolm Gladwell discusses this phenomenon in "The Deep End" (2018).

### In-Text Citations (Notes-Bibliography System)

In the notes-bibliography system, you use footnotes or endnotes. A superscript number in your text refers to a corresponding note at the bottom of the page or the end of the document. The first time you cite a source, the note includes the full citation details. Subsequent citations of the same source



use a shortened format.

The abbreviated note includes the author's last name, the episode title, and the page number if applicable (though page numbers are rare for podcasts). If you are referencing the podcast series generally in a note, the format would be adjusted accordingly.
