Understanding the Chicago Manual of Style: Author-Date System

The Chicago Manual of Style (CMOS) is a widely respected style guide offering two primary systems for citation: notes-bibliography and author-date. The author-date system, which is the focus of this discussion, is often favored in the social sciences and natural sciences for its directness and ease of use. The alphabetical ordering by author's last name is a critical organizational principle.

Citing Books: Author-Date Examples

Single-Author Book

For a book with one author, the bibliography entry begins with the author's last name, followed by a comma and their first name. Then comes the year of publication in parentheses, followed by the title of the book in italics. Finally, include the place of publication and the publisher.

Book with Two or Three Authors

When a book has two or three authors, all authors' names are listed in the bibliography entry, with the first author's name inverted. Subsequent authors are listed in their normal first-name-last-name order. The order of authors in the bibliography should match their order on the title page.

- Bibliography Example: Jones, Sarah, and David Lee. 2019. *Foundations of Science*. New York: Academic Publishing.
- In-text Citation Example: (Jones and Lee 2019).

Book with More Than Three Authors

For works with four or more authors, the Chicago author-date system simplifies the bibliography entry. You list only the first author's name, followed by "et al." (Latin for "and others").

Edited Book

When citing an edited book where you are referencing the work as a whole (not a specific chapter by a contributor), the editor(s) are listed in the same way as authors, but with the addition of "ed." (for one editor) or "eds." (for multiple editors) after their name(s).

- Bibliography Example: Miller, Robert, ed. 2018. *Readings in Environmental Policy*. Berkeley: University of California Press.
- In-text Citation Example: (Miller 2018).

Chapter in an Edited Book

If you are citing a specific chapter within an edited collection, the entry in the bibliography will include the chapter author, the chapter title, the editor(s), the book title, page numbers for the chapter, and publication details.

- Bibliography Example: Garcia, Maria. 2017. "The Impact of Globalization." In *Global Challenges and Solutions*, edited by Peter Chen, 112-135. Boston: Pearson.

Citing Journal Articles: Author-Date Examples

Journal articles are a common source in academic research, and their citation in the Chicago author-date system requires specific details about the journal, volume, and issue.

Journal Article with One Author

For a journal article, the author's last name comes first, followed by their full name. The article title is enclosed in quotation marks. The journal title is italicized. Journal Article with Two or Three Authors

Similar to books, when a journal article has two or three authors, all are listed in the bibliography. The first author's name is inverted. The order of authors remains consistent with the article's title page.

- Bibliography Example: Wilson, Thomas, and Anna Green. 2021. "Sustainable Urban Development." *Environmental Planning Review* 32 (4): 55-78.
- In-text Citation Example: (Wilson and Green 2021).

Journal Article with More Than Three Authors

For journal articles with four or more authors, the bibliography entry lists only the first author's name, followed by "et al."

- Bibliography Example: Kim, Ji-hoon, et al. 2023. "AI in Healthcare." *Medical Informatics Quarterly* 15 (1): 88-105.
- In-text Citation Example: (Kim et al. 2023).

Journal Article Accessed Online (with DOI)

When citing a journal article found online, if a Digital Object Identifier (DOI) is available, it is preferred over a URL. The DOI provides a stable link to the article.

- Bibliography Example: Chen, Li. 2020. "The Future of Renewable Energy." *Energy Policy Journal* 50: 150-165. doi:10.1016/j.enpol.2020.01.020.
- In-text Citation Example: (Chen 2020).

Citing Websites and Online Sources: Author-Date Examples

The internet has become an indispensable source of information, and the Chicago manual provides guidelines for citing websites, web pages, and online articles.

Website with an Author

If a website has a clearly identified author (individual or organization), treat it similarly to a book or article. Include the author's name, the title of the specific page or article in quotation marks, the website name in italics, and the publication date. If no publication date is available, use "n.d." (no date).

Website Without a Specific Author

When a website lacks a discernible author, the entry begins with the title of the page or article. Follow this with the website name, and then the date of publication or last update. If these are unavailable, the date of access is crucial.

Online Article or Blog Post

For individual articles or blog posts published online, the format is similar to a journal article but adapted for web content. Include the author, article title in quotes, website name in italics, and publication date. A URL is essential.

Citing Other Common Sources: Author-Date Examples

Newspaper Article

For newspaper articles, include the author (if known), article title in quotation marks, newspaper title in italics, and the full date of publication.

Report from a Government Agency or Organization

Dissertation or Thesis

When citing a dissertation or thesis, include the author, the dissertation title in italics, the degree awarded (e.g., PhD dissertation, Master's thesis), the university, and the year of completion.

In-Text Citations in the Author-Date System

Basic In-Text Citation

When citing a work with four or more authors, only the first author's last name is given, followed by "et al.": (Williams et al. 2020).
