Edited Volumes and Contributions to Anthologies

page, the website name (*italicized*), the publication date or last updated date, and the URL. A retrieval date is often included if the content is likely to change.

Example:

9. "About Us," *The Center for Pastor Theologians*, last updated September 15, 2023, accessed October 26, 2023, <https://www.centerforpastortheologians.org/about-us>.

Audiovisual Materials and Social Media
