NOTES-BIBLIOGRAPHY SYSTEM IN RELIGIOUS SOCIOLOGY

AUTHOR-DATE SYSTEM FOR SOCIOLOGICAL WORKS

WHILE THE NOTES-BIBLIOGRAPHY SYSTEM IS COMMON FOR ORIGINAL RELIGIOUS SOURCES, THE AUTHOR-DATE SYSTEM IS FREQUENTLY EMPLOYED FOR CITING CONTEMPORARY SOCIOLOGICAL STUDIES AND THEORETICAL WORKS. THIS SYSTEM USES PARENTHETICAL IN-TEXT CITATIONS THAT INCLUDE THE AUTHOR'S LAST NAME AND THE PUBLICATION YEAR, FOLLOWED BY A FULL BIBLIOGRAPHY AT THE END OF THE WORK. THIS APPROACH IS HIGHLY EFFICIENT FOR REFERENCING A LARGE VOLUME OF SECONDARY SOCIOLOGICAL LITERATURE, ALLOWING READERS TO QUICKLY LOCATE THE SOURCE OF INFORMATION AND ASSESS ITS CREDIBILITY.

A: THE AUTHOR-DATE SYSTEM IS OFTEN USED IN RELIGIOUS SOCIOLOGY FOR CITING CONTEMPORARY SOCIOLOGICAL STUDIES AND THEORETICAL WORKS. IT ALLOWS FOR EFFICIENT IN-TEXT REFERENCING WITH PARENTHETICAL CITATIONS AND A COMPREHENSIVE BIBLIOGRAPHY, FACILITATING THE INTEGRATION OF SECONDARY SCHOLARLY LITERATURE.
