EVOLUTION OF GENERAL CITATION PRINCIPLES

THE CORE PRINCIPLES OF CHICAGO-STYLE CITATION REMAIN CONSISTENT: PROVIDING ENOUGH INFORMATION FOR READERS TO LOCATE THE ORIGINAL SOURCE AND GIVING CREDIT TO ORIGINAL AUTHORS. IN SOME INSTANCES, IT MAY BE CLEARER TO REPEAT THE SHORTENED CITATION RATHER THAN RELYING HEAVILY ON "IBID.," ESPECIALLY IN LENGTHY FOOTNOTES OR ENDNOTES.

THE INTENTION BEHIND THIS SHIFT IS TO PREVENT POTENTIAL CONFUSION FOR READERS NAVIGATING COMPLEX SETS OF NOTES. CLARITY FOR THE READER IS PARAMOUNT, AND "IBID." CAN SOMETIMES OBSCURE THE SOURCE IF THE PRECEDING NOTE REFERS TO A DIFFERENT WORK OR PAGE NUMBER THAN ANTICIPATED.

NEW GUIDANCE FOR CITING DIGITAL RESOURCES IN NOTES
