Understanding the Two CMOS Citation Systems

The *Chicago Manual of Style*, in its 17th edition, offers writers a choice between two primary citation methods: the notes-bibliography system and the author-date system. While both aim to acknowledge sources accurately, they differ significantly in their application within the text and the structure of the final bibliography or reference list. The Notes-Bibliography System: In-Text Citations and Full Bibliographies

The notes-bibliography system is a cornerstone of scholarly communication in many fields, offering a detailed and flexible approach to source citation. Its application involves a two-part mechanism: the in-text citation and the comprehensive bibliography.

In-Text Citations: Footnotes and Endnotes

In the notes-bibliography system, superscript numbers are placed directly after the quotation or paraphrased idea being referenced. These numbers serve as pointers to corresponding notes. The Bibliography

The bibliography is a standalone section at the end of the work that lists all sources that have been cited. Entries in the bibliography are arranged alphabetically by the author's last name. The format for each entry mirrors that of the first note but is presented as a full entry, typically with hanging indents for readability. This section allows readers to quickly identify and locate the full details of every source consulted and referenced in the text, thereby supporting the author's arguments and enabling further research.

The Author-Date System: Parenthetical Citations and Reference Lists

The author-date system, while different in presentation from the notes-bibliography system, serves the same fundamental purpose: to give credit to sources and allow readers to locate them. This method is often preferred for its conciseness within the main body of the text.

Parenthetical Citations

Parenthetical citations are inserted directly into the text, usually at the end of a sentence or clause. They typically include the author's last name and the year of publication, enclosed in parentheses. If a direct quotation is used, the page number(s) should also be included. For instance, a citation might appear as (Smith 2021, 112) for a direct quote or (Jones 2019) for a general reference to Jones's work.

It is important to note how the citation interacts with punctuation. If the parenthetical reference concludes a sentence, the period follows the closing parenthesis. If it interrupts a sentence, commas are used according to standard punctuation rules.

The Reference List

The reference list, also known as a works cited list in some styles, accompanies the author-date system. It appears at the end of the document and includes full bibliographic information for every source cited in the text. Like the bibliography in the notes-system, the reference list is alphabetized by the author's last name. Each entry provides all the necessary details for a reader to find the original source, including author, title, publication information, and any other relevant data.

Websites and Online Resources

Citing online sources has become increasingly important. CMOS provides guidance for websites, including the author or sponsoring organization, title of the specific page or document, website name, and a stable URL. Including an access date is often recommended for online resources, as their content can change.

Example (Notes-Bibliography, first note):

Advanced CMOS Citation Scenarios

Beyond the common source types, the 17th edition of the Chicago Manual of Style addresses a host of more complex citation scenarios that writers may encounter in their research. These often involve multiple authors, revised editions, or less conventional publication formats.

When a work has two or three authors, all names are typically included in both notes and bibliographies/reference lists. between printings.
