## Understanding the Chicago Manual of Style (CMOS) Citation System

## **Citing Books with Author Prefaces: Footnotes and Endnotes**

When citing a book that includes a preface written by the author using the Chicago Manual of Style's notes-bibliography system, the citation in the footnote or endnote needs to be precise. The primary goal is to direct the reader to the specific part of the book being referenced. The format generally follows the standard book citation but includes specific details about the preface.

### **Basic Footnote/Endnote Structure**

The fundamental structure for a footnote or endnote referencing a book preface written by the author involves identifying the author, the title of the book, and then specifying the preface and the page number(s) on which it appears. It is crucial to distinguish between the author of the preface and the author of the main text if they differ, though for this focus, we assume they are the same individual. The initial citation in a footnote/endnote is typically a full citation, while subsequent citations to the same source can

## Formatting the Preface Reference

According to CMOS, when referencing the preface written by the author, you should clearly indicate "preface" and then provide the relevant page number(s). The title of the book is italicized. The author's name appears in the standard order (first name, last name) in the footnote/endnote, unlike in the bibliography where it is inverted for the first author.

- First occurrence in a note: Author First Name Last Name, "Title of Book," (City of Publication: Publisher, Year), preface, page(s).

For example, if you are citing a preface by Jane Doe in a book titled *The Art of Writing*, published in 2023, and the preface is on pages vii-xi, the footnote would look like this:

Jane Doe, "The Art of Writing," (Chicago: University of Chicago Press, 2023), preface, vii-xi.

## Subsequent Citations

Once a source has been fully cited in a note, subsequent references to the same work can be abbreviated. This helps to avoid redundancy and keeps the notes concise. For an author preface, this often means including the author's last name, a shortened version of the title (if necessary, though not always for a preface), and the page number.

For instance, a subsequent note referring to the same preface would be:

Doe, "The Art of Writing," preface, x.

If the preface is particularly lengthy or you are referencing multiple parts of it, you might even be able to shorten it further if the context is clear, but always err on the side of clarity. The key is that the reader can easily identify the source and the specific location.

## Formatting the Bibliography Entry for Books

## with Author Prefaces

The bibliography is a comprehensive list of all sources cited in the notes, presented at the end of the work. The formatting for a bibliography entry for a book with an author-written preface follows the standard book format but includes the necessary indication of the preface. The most significant difference from footnotes is the inversion of the author's name for the first author listed.

## Standard Bibliography Format

The general format for a book in the bibliography is Author Last Name, Author First Name. Title of Book. City of Publication: Publisher, Year.

When including a preface written by the author, this information is integrated into the citation. It's important to note that in CMOS, you typically do not include the word "preface" directly in the main bibliography entry for the book itself unless the entire book is essentially a collection of prefaces or a standalone preface. Instead, the preface is referenced by its page numbers within the main book citation, and the note clarifies it's the preface.

## Indicating the Preface in the Bibliography

However, if you are citing the preface as a distinct element or if the publisher specifically labels it as such, you might include it. The most common and clear method, as per Chicago style, is to cite the book as a whole and then specify the preface and page numbers in the note. For the bibliography, the standard book entry suffices. The distinction between the main text and the preface is primarily made in the notes.

Let's revisit the example of Jane Doe's book:

Doe, Jane. *The Art of Writing*. Chicago: University of Chicago Press, 2023.

Within the notes, the distinction is made. If there's a specific reason to highlight the preface as a separately considered element in the bibliography, one might list it with a slightly different structure, but this is less common for a standard author-written preface. The primary and most straightforward approach is to cite the book, and then in the note, specify "preface" and the page numbers.

## **When the Preface is a Separate Work**

It's worth noting that some books might feature a preface written by someone other than the author of the main text, or a preface that is a substantial, independently published work in itself. In such cases, the citation format can evolve. However, for the focus of this article—a preface written by the author of the main text—the standard book citation in the bibliography, with specific notes, is the rule.

## **Key Considerations for Prefaces Written by the Author**

When dealing with author-written prefaces, several specific considerations come into play that can affect how you cite them according to the Chicago Manual of Style. These nuances ensure accuracy and prevent misinterpretation of your sources.

### **Authorial Voice and Intent**

Prefaces are frequently, though not always, paginated with Roman numerals (i, ii, iii, etc.) rather than Arabic numerals, which are used for the main body of the book. When citing these pages in your footnotes or endnotes, you must accurately reflect this numbering. If the preface spans both Roman and Arabic numerals (e.g., ending on a Roman numeral page and the main text starting on an Arabic numeral page), ensure your citation reflects the specific page range within the preface.

### **Distinguishing from Forewords or Introductions**

It is crucial to distinguish between a preface, a foreword, and an introduction. A preface is typically written by the author of the main text. A foreword is usually written by someone other than the author, often an

expert in the field or someone who has a significant relationship with the author or the subject matter. An introduction is part of the main text, written by the author, and functions as a more formal opening to the subject. Ensure you are correctly identifying the section you are citing and use the appropriate term ("preface," "foreword," or "introduction") in your notes and bibliography.

## **Common Pitfalls and How to Avoid Them**

Navigating citation styles can be complex, and even experienced writers can make mistakes. When citing author-written prefaces, several common pitfalls can arise. Being aware of these issues can help you avoid them and maintain the integrity of your research.

### **Inconsistent Formatting**

One of the most frequent errors is inconsistency in formatting between footnotes/endnotes and the bibliography. Remember that author names are inverted only in the bibliography. Page numbering conventions also need to be consistent, particularly with Roman numerals for prefaces.

A citation is incomplete without precise page numbers. Simply stating "preface" is insufficient. You must provide the specific page(s) where the referenced information can be found. This is critical for enabling your readers to locate the source material easily.

### **Incorrectly Handling Multiple Authors**

While this article focuses on author-written prefaces, it's worth briefly

noting that if a book has multiple authors and the preface is by one specific author, this detail should be handled according to CMOS rules for multiple authors, though the focus remains on the preface itself.

### **Works Where the Preface is the Main Focus**

In such situations, your citation would still identify it as a preface, but the emphasis in your text would highlight its importance. The citation mechanics, however, generally remain consistent.
