Understanding Prefatory Material in Academic Citations

The bibliography entry for the same book would be:

- Doe, Jane. "Foreword." In *The Art of Academic Writing*, by John Smith, i-xvi. New York: Publishers Inc., 2023.

Notice the slight difference in punctuation and capitalization between the note and the bibliography entry. In the bibliography, the title of the contribution is in quotation marks, and the main book title is italicized. The expert's name is inverted in the bibliography. The page numbers for the preface are generally presented using Roman numerals, as they typically precede the Arabic-numbered main text.

Author-Date System: Referencing Books with Expert Prefaces

The Author-Date system, prevalent in social sciences and natural sciences, relies on parenthetical in-text citations keyed to a reference list at the end of the work. Citing prefatory material follows a similar logic of identifying the contributor and the source.
