UNDERSTANDING AND IMPLEMENTING CMOS CORRECTLY WILL NOT ONLY STREAMLINE THE WRITING PROCESS BUT ALSO SIGNIFICANTLY ENHANCE THE PROFESSIONAL PRESENTATION OF YOUR DOCTORAL WORK, DEMONSTRATING YOUR COMMITMENT TO ACADEMIC RIGOR. THIS ARTICLE AIMS TO DEMYSTIFY THE APPLICATION OF CMOS FOR PSYCHOLOGY DISSERTATIONS, EMPOWERING YOU TO NAVIGATE ITS REQUIREMENTS WITH CONFIDENCE.

UNDERSTANDING THE CHICAGO MANUAL OF STYLE FOR PSYCHOLOGY DISSERTATIONS

THE CHICAGO MANUAL OF STYLE (CMOS) IS A WIDELY RESPECTED AND COMPREHENSIVE STYLE GUIDE THAT OFFERS DETAILED INSTRUCTIONS FOR ALL ASPECTS OF SCHOLARLY WRITING. FOR DISSERTATIONS IN PSYCHOLOGY, CMOS PROVIDES A ROBUST FRAMEWORK FOR PRESENTING COMPLEX RESEARCH FINDINGS IN A CLEAR, ORGANIZED, AND STANDARDIZED MANNER. WHILE PSYCHOLOGY DEPARTMENTS MAY SOMETIMES ADOPT VARIATIONS OR SPECIFIC APPENDICES FROM OTHER STYLES LIKE APA, MANY INSTITUTIONS AND INDIVIDUAL ADVISORS STILL DEFAULT TO OR RECOMMEND CMOS FOR ITS THOROUGHNESS, PARTICULARLY CONCERNING BIBLIOGRAPHIC ENTRIES AND MANUSCRIPT STRUCTURE.

THE CORE STRENGTH OF CMOS FOR PSYCHOLOGICAL DISSERTATIONS LIES IN ITS DUAL CITATION SYSTEMS: THE NOTES-BIBLIOGRAPHY SYSTEM AND THE AUTHOR-DATE SYSTEM. WHILE THE AUTHOR-DATE SYSTEM IS MORE PREVALENT IN THE NATURAL SCIENCES AND SOME SOCIAL SCIENCES, MANY PSYCHOLOGY PROGRAMS FIND THE NOTES-BIBLIOGRAPHY SYSTEM BENEFICIAL FOR ITS FLEXIBILITY IN INCORPORATING EXTENSIVE EXPLANATORY NOTES, WHICH CAN BE INVALUABLE FOR DETAILING METHODOLOGICAL NUANCES OR THEORETICAL DIGRESSIONS COMMON IN PSYCHOLOGICAL RESEARCH. UNDERSTANDING WHICH SYSTEM YOUR DEPARTMENT OR ADVISOR PREFERS IS THE CRUCIAL FIRST STEP IN APPLYING CMOS EFFECTIVELY. THIS CHOICE SIGNIFICANTLY IMPACTS HOW YOU WILL INTEGRATE SOURCE MATERIAL THROUGHOUT YOUR DOCUMENT, FROM THE BODY OF YOUR TEXT TO THE FINAL REFERENCE LIST.

MANUSCRIPT PREPARATION: THE FOUNDATION OF YOUR DISSERTATION

PROPER MANUSCRIPT PREPARATION IS PARAMOUNT FOR A PROFESSIONAL-LOOKING DISSERTATION. THE CHICAGO MANUAL OF STYLE PROVIDES GUIDELINES FOR SEVERAL KEY ELEMENTS THAT CONTRIBUTE TO THE OVERALL STRUCTURE AND READABILITY OF YOUR WORK. THIS INCLUDES THE CAREFUL ORGANIZATION OF PRELIMINARY PAGES, THE BODY OF THE TEXT, AND THE APPENDED MATERIALS.

PRELIMINARY PAGES: SETTING THE STAGE

THE PRELIMINARY PAGES OF YOUR PSYCHOLOGY DISSERTATION, AS OUTLINED BY CMOS, TYPICALLY INCLUDE THE TITLE PAGE, ABSTRACT, TABLE OF CONTENTS, LIST OF TABLES, LIST OF FIGURES, AND ACKNOWLEDGMENTS. EACH OF THESE SECTIONS HAS SPECIFIC FORMATTING REQUIREMENTS. FOR INSTANCE, THE TITLE PAGE SHOULD CLEARLY STATE THE DISSERTATION TITLE, YOUR NAME, THE DEGREE SOUGHT, THE DEPARTMENT, THE UNIVERSITY, AND THE DATE OF SUBMISSION. THE ABSTRACT, A CONCISE SUMMARY OF YOUR RESEARCH, SHOULD ADHERE TO WORD COUNT LIMITS OFTEN SPECIFIED BY YOUR UNIVERSITY AND EFFECTIVELY ENCAPSULATE YOUR RESEARCH QUESTION, METHODS, RESULTS, AND CONCLUSIONS.

CHAPTER STRUCTURE AND FORMATTING

A TYPICAL PSYCHOLOGY DISSERTATION STRUCTURED ACCORDING TO CMOS PRINCIPLES WILL LIKELY INCLUDE CHAPTERS COVERING AN INTRODUCTION, LITERATURE REVIEW, METHODOLOGY, RESULTS, DISCUSSION, AND CONCLUSION. EACH CHAPTER SHOULD BEGIN ON A NEW PAGE, WITH CLEAR HEADINGS AND SUBHEADINGS THAT FOLLOW A CONSISTENT HIERARCHICAL STRUCTURE. CMOS OFFERS GUIDANCE ON THE FORMATTING OF THESE HEADINGS, ENSURING A LOGICAL FLOW OF INFORMATION AND EASY NAVIGATION FOR READERS. CONSISTENT PAGE NUMBERING, MARGINS, AND FONT CHOICES ARE ALSO CRUCIAL FOR MAINTAINING A PROFESSIONAL APPEARANCE.

APPENDICES AND SUPPLEMENTARY MATERIAL

APPENDICES ARE OFTEN NECESSARY IN PSYCHOLOGY DISSERTATIONS TO HOUSE SUPPLEMENTARY MATERIALS THAT ARE TOO LENGTHY OR DETAILED FOR THE MAIN BODY. THIS CAN INCLUDE RAW DATA, DETAILED STATISTICAL OUTPUTS, SURVEY INSTRUMENTS, INTERVIEW PROTOCOLS, OR PARTICIPANT CONSENT FORMS. CMOS PROVIDES CLEAR INSTRUCTIONS ON HOW TO FORMAT APPENDICES, TYPICALLY DESIGNATING THEM AS APPENDIX A, APPENDIX B, AND SO FORTH, EACH WITH ITS OWN TITLE. ENSURING THESE MATERIALS ARE PROPERLY LABELED AND REFERENCED WITHIN THE MAIN TEXT IS VITAL FOR THE INTEGRITY OF YOUR RESEARCH PRESENTATION.

CITATIONS AND REFERENCES: ATTRIBUTING YOUR SOURCES ACCURATELY

ACCURATE AND CONSISTENT CITATION IS ONE OF THE MOST CRITICAL ASPECTS OF ACADEMIC WRITING, AND THE CHICAGO MANUAL OF STYLE OFFERS TWO COMPREHENSIVE SYSTEMS TO ACHIEVE THIS. FOR DISSERTATIONS IN PSYCHOLOGY, THE CHOICE BETWEEN THE NOTES-BIBLIOGRAPHY SYSTEM AND THE AUTHOR-DATE SYSTEM OFTEN DEPENDS ON DEPARTMENTAL GUIDELINES, BUT BOTH DEMAND METICULOUS ATTENTION TO DETAIL.

THE NOTES-BIBLIOGRAPHY SYSTEM IN PSYCHOLOGY

THE NOTES-BIBLIOGRAPHY SYSTEM UTILIZES FOOTNOTES OR ENDNOTES FOR IN-TEXT CITATIONS AND A COMPREHENSIVE BIBLIOGRAPHY AT THE END OF THE DOCUMENT. IN THIS SYSTEM, A SUPERScript NUMBER IS PLACED AFTER THE RELEVANT TEXT, CORRESPONDING TO A NUMBERED NOTE THAT PROVIDES THE CITATION DETAILS. FOR PSYCHOLOGICAL RESEARCH, THIS SYSTEM CAN BE PARTICULARLY USEFUL FOR EXPLAINING COMPLEX THEORETICAL UNDERPINNINGS OR METHODOLOGICAL CONSIDERATIONS WITHOUT DISRUPTING THE FLOW OF THE MAIN TEXT. THE BIBLIOGRAPHY THEN LISTS ALL SOURCES CITED, ALPHABETIZED BY AUTHOR'S LAST NAME.

THE AUTHOR-DATE SYSTEM IN PSYCHOLOGY

THE AUTHOR-DATE SYSTEM, MORE COMMON IN EMPIRICAL PSYCHOLOGY, INTEGRATES CITATIONS DIRECTLY INTO THE TEXT, TYPICALLY IN PARENTHESES: (AUTHOR, YEAR). FOR EXAMPLE, A CITATION MIGHT APPEAR AS (SKINNER, 1953). WHEN REFERRING TO A SPECIFIC PASSAGE, A PAGE NUMBER IS INCLUDED: (SKINNER, 1953, p. 15). SIMILAR TO THE NOTES-BIBLIOGRAPHY SYSTEM, A REFERENCE LIST FOLLOWS THE BODY OF THE DISSERTATION, PROVIDING FULL BIBLIOGRAPHIC DETAILS FOR ALL IN-TEXT CITATIONS, ALPHABETIZED BY AUTHOR'S LAST NAME. THIS SYSTEM IS PRAISED FOR ITS CONCISENESS AND EASE OF TRACKING SOURCES WITHIN THE NARRATIVE.

KEY ELEMENTS OF CMOS CITATIONS

REGARDLESS OF THE CHOSEN SYSTEM, CMOS PROVIDES SPECIFIC RULES FOR FORMATTING CITATIONS FOR VARIOUS TYPES OF SOURCES COMMONLY FOUND IN PSYCHOLOGICAL RESEARCH. THIS INCLUDES:

- JOURNAL ARTICLES: INCLUDING AUTHOR(S), YEAR, ARTICLE TITLE, JOURNAL TITLE, VOLUME, ISSUE, AND PAGE NUMBERS.
- BOOKS: INCLUDING AUTHOR(S), YEAR, BOOK TITLE, PUBLISHER, AND LOCATION.
- BOOK CHAPTERS: INCLUDING CHAPTER AUTHOR(S), CHAPTER TITLE, BOOK EDITOR(S), BOOK TITLE, AND PUBLICATION DETAILS.
- WEBSITES AND ONLINE RESOURCES: INCLUDING AUTHOR (IF AVAILABLE), PUBLICATION DATE, TITLE OF THE PAGE OR DOCUMENT, WEBSITE NAME, AND URL.

PAY CLOSE ATTENTION TO PUNCTUATION, CAPITALIZATION, AND THE USE OF ITALICS FOR TITLES, AS CMOS PRESCRIBES PRECISE FORMATTING FOR EACH ELEMENT TO ENSURE CONSISTENCY AND CLARITY.

FORMATTING TABLES AND FIGURES: VISUALIZING YOUR DATA EFFECTIVELY

EFFECTIVE DATA VISUALIZATION IS CRUCIAL IN PSYCHOLOGY DISSERTATIONS TO PRESENT QUANTITATIVE AND QUALITATIVE FINDINGS CLEARLY AND CONCISELY. THE CHICAGO MANUAL OF STYLE OFFERS DETAILED GUIDANCE ON HOW TO FORMAT TABLES AND FIGURES TO MAINTAIN CONSISTENCY AND PROFESSIONALISM THROUGHOUT YOUR DOCUMENT.

FORMATTING TABLES

TABLES IN A PSYCHOLOGY DISSERTATION SHOULD BE CLEARLY LABELED WITH A TITLE THAT SUCCINCTLY DESCRIBES THEIR CONTENT. CMOS RECOMMENDS THAT TABLE NUMBERS (E.G., TABLE 1, TABLE 2) BE PLACED ABOVE THE TITLE. THE BODY OF THE TABLE SHOULD BE ORGANIZED LOGICALLY, WITH CLEAR COLUMN AND ROW HEADINGS. WHILE CMOS GENERALLY FAVORS MINIMAL USE OF VERTICAL RULES, HORIZONTAL RULES ARE TYPICALLY USED TO SEPARATE THE COLUMN HEADS FROM THE DATA AND TO DELINEATE THE TABLE FROM SURROUNDING TEXT. SPECIAL CARE SHOULD BE TAKEN TO ENSURE THAT ALL ABBREVIATIONS AND SYMBOLS USED WITHIN THE TABLE ARE EXPLAINED, EITHER IN A NOTE BELOW THE TABLE OR WITHIN THE COLUMN/ROW HEADINGS THEMSELVES. STATISTICAL SIGNIFICANCE INDICATORS SHOULD ALSO BE CLEARLY DEFINED.

FORMATTING FIGURES

FIGURES, WHICH CAN INCLUDE GRAPHS, CHARTS, DIAGRAMS, AND IMAGES, REQUIRE SIMILAR ATTENTION TO DETAIL. EACH FIGURE SHOULD BE NUMBERED SEQUENTIALLY (E.G., FIGURE 1, FIGURE 2) AND HAVE A DESCRIPTIVE CAPTION PLACED BELOW THE FIGURE. THE CAPTION SHOULD PROVIDE ENOUGH INFORMATION FOR THE READER TO UNDERSTAND THE VISUAL REPRESENTATION WITHOUT NEEDING TO REFER BACK TO THE MAIN TEXT EXTENSIVELY. ANY AXES ON GRAPHS SHOULD BE CLEARLY LABELED, INCLUDING UNITS OF MEASUREMENT. FOR COMPLEX FIGURES OR IMAGES SOURCED FROM EXTERNAL PUBLICATIONS, PROPER ATTRIBUTION OF THE

ORIGINAL SOURCE, AS PER CMOS CITATION GUIDELINES, IS ESSENTIAL TO AVOID PLAGIARISM.

INTEGRATING TABLES AND FIGURES INTO THE TEXT

CMOS EMPHASIZES THAT TABLES AND FIGURES SHOULD BE PLACED AS CLOSE AS POSSIBLE TO THEIR FIRST MENTION IN THE TEXT. WHEN REFERRING TO A TABLE OR FIGURE IN YOUR NARRATIVE, USE ITS NUMBER (E.G., "AS SHOWN IN TABLE 3," OR "FIGURE 1 ILLUSTRATES..."). ENSURE THAT THE TEXT EFFECTIVELY LEADS THE READER TO UNDERSTAND THE DATA PRESENTED IN THE VISUAL ELEMENTS, AND CONVERSELY, THAT THE TABLES AND FIGURES EFFECTIVELY SUPPORT AND CLARIFY THE POINTS BEING MADE IN THE TEXT. CONSISTENCY IN FONT, SIZE, AND STYLE FOR ALL VISUAL ELEMENTS WITHIN THE DISSERTATION IS KEY TO A POLISHED FINAL PRODUCT.

SPECIAL CONSIDERATIONS FOR PSYCHOLOGY DISSERTATIONS

WHILE THE GENERAL PRINCIPLES OF THE CHICAGO MANUAL OF STYLE APPLY BROADLY, CERTAIN ASPECTS REQUIRE PARTICULAR ATTENTION WHEN USED FOR PSYCHOLOGY DISSERTATIONS. THE NATURE OF PSYCHOLOGICAL RESEARCH, OFTEN INVOLVING EMPIRICAL DATA, STATISTICAL ANALYSIS, AND THEORETICAL FRAMEWORKS, NECESSITATES A NUANCED APPLICATION OF THE STYLE GUIDE.

REPORTING STATISTICAL DATA

CMOS PROVIDES GUIDANCE ON REPORTING STATISTICAL INFORMATION, BUT MANY PSYCHOLOGY DEPARTMENTS WILL DEFER TO SPECIFIC CONVENTIONS WITHIN THE FIELD, OFTEN ALIGNING WITH APA STYLE FOR STATISTICAL REPORTING. HOWEVER, IF ADHERING STRICTLY TO CMOS, ENSURE THAT STATISTICAL VALUES, SUCH AS P-VALUES, EFFECT SIZES, AND CONFIDENCE INTERVALS, ARE PRESENTED CLEARLY AND CONSISTENTLY. CMOS RECOMMENDS USING STANDARD ABBREVIATIONS FOR STATISTICAL TESTS AND PARAMETERS. WHEN IN DOUBT, CONSULT YOUR ADVISOR OR DEPARTMENTAL GUIDELINES REGARDING THE INTEGRATION OF STATISTICAL REPORTING WITH CMOS PRINCIPLES.

ETHICAL CONSIDERATIONS AND PARTICIPANT DATA

PSYCHOLOGY DISSERTATIONS OFTEN INVOLVE HUMAN PARTICIPANTS, RAISING ETHICAL CONSIDERATIONS REGARDING CONFIDENTIALITY AND ANONYMITY. WHILE CMOS DOESN'T DICTATE ETHICAL PRACTICES, IT'S IMPORTANT THAT YOUR DISSERTATION, IN ITS DESCRIPTION OF METHODS AND PRESENTATION OF RESULTS, RESPECTS THESE ETHICAL GUIDELINES. ANY MENTION OF PARTICIPANT IDENTIFIERS, EVEN ANONYMIZED ONES, SHOULD BE HANDLED WITH EXTREME CARE, AND THE DISSERTATION SHOULD REFLECT ADHERENCE TO INSTITUTIONAL REVIEW BOARD (IRB) PROTOCOLS. THE PRESENTATION OF DATA, ESPECIALLY IN TABLES AND FIGURES, MUST ENSURE THAT NO INDIVIDUAL CAN BE IDENTIFIED.

THE CHICAGO MANUAL OF STYLE FOR DISSERTATIONS IN PSYCHOLOGY IS A POWERFUL TOOL FOR PRODUCING A POLISHED, CREDIBLE, AND IMPACTFUL SCHOLARLY WORK. BY UNDERSTANDING ITS CORE PRINCIPLES AND APPLYING THEM DILIGENTLY TO MANUSCRIPT PREPARATION, CITATION, AND THE PRESENTATION OF DATA, YOU CAN ENSURE YOUR RESEARCH IS COMMUNICATED EFFECTIVELY AND ADHERES TO THE HIGHEST ACADEMIC STANDARDS.

FAQ

Q: WHAT IS THE PRIMARY DIFFERENCE BETWEEN THE NOTES-BIBLIOGRAPHY SYSTEM AND THE AUTHOR-DATE SYSTEM IN THE CHICAGO MANUAL OF STYLE, AND WHICH IS TYPICALLY PREFERRED FOR PSYCHOLOGY DISSERTATIONS?

A: THE PRIMARY DIFFERENCE LIES IN HOW SOURCES ARE CITED WITHIN THE TEXT. THE NOTES-BIBLIOGRAPHY SYSTEM USES NUMBERED FOOTNOTES OR ENDNOTES, ALLOWING FOR MORE EXTENSIVE EXPLANATORY COMMENTARY. THE AUTHOR-DATE SYSTEM EMBEDS CITATIONS DIRECTLY IN THE TEXT AS (AUTHOR, YEAR). WHILE MANY PSYCHOLOGY PROGRAMS TRADITIONALLY LEANED TOWARDS APA STYLE, WHICH USES AUTHOR-DATE, SOME INSTITUTIONS OR ADVISORS MAY RECOMMEND OR REQUIRE CMOS'S NOTES-BIBLIOGRAPHY SYSTEM FOR DISSERTATIONS DUE TO ITS FLEXIBILITY. IT IS CRUCIAL TO CHECK YOUR SPECIFIC DEPARTMENTAL GUIDELINES.

Q: HOW DOES THE CHICAGO MANUAL OF STYLE HANDLE THE FORMATTING OF STATISTICAL RESULTS IN PSYCHOLOGY DISSERTATIONS?

A: CMOS PROVIDES GENERAL GUIDELINES FOR REPORTING NUMBERS AND STATISTICS. HOWEVER, FOR SPECIFIC STATISTICAL REPORTING CONVENTIONS, SUCH AS HOW TO PRESENT P-VALUES, EFFECT SIZES, OR TEST STATISTICS (E.G., T-TESTS, ANOVAS), PSYCHOLOGY DISSERTATIONS OFTEN FOLLOW CONVENTIONS MORE CLOSELY ALIGNED WITH APA STYLE. ALWAYS CONSULT YOUR DEPARTMENT'S SPECIFIC REQUIREMENTS OR YOUR DISSERTATION ADVISOR FOR GUIDANCE ON STATISTICAL REPORTING WITHIN THE CMOS FRAMEWORK.

Q: ARE THERE SPECIFIC GUIDELINES WITHIN THE CHICAGO MANUAL OF STYLE FOR FORMATTING PSYCHOLOGICAL SCALES OR QUESTIONNAIRES WHEN THEY ARE INCLUDED IN A DISSERTATION?

A: CMOS PROVIDES GENERAL GUIDANCE FOR FORMATTING APPENDICES, WHICH IS WHERE SCALES AND QUESTIONNAIRES ARE TYPICALLY PLACED. EACH ITEM IN THE APPENDIX SHOULD BE CLEARLY LABELED AND PRESENTED IN A READABLE FORMAT. IF THE SCALE OR QUESTIONNAIRE IS PUBLISHED, YOU WILL NEED TO CITE IT APPROPRIATELY ACCORDING TO CMOS RULES FOR BOOKS OR ARTICLES. FOR CUSTOM-DEVELOPED INSTRUMENTS, A CLEAR DESCRIPTION AND THE FULL INSTRUMENT SHOULD BE PROVIDED, OFTEN WITHIN AN APPENDIX, WITH PROPER ATTRIBUTION TO ITS ORIGIN.

Q: WHAT ARE THE KEY ELEMENTS TO INCLUDE IN THE ABSTRACT OF A PSYCHOLOGY DISSERTATION WHEN FOLLOWING THE CHICAGO MANUAL OF STYLE?

A: WHILE CMOS PROVIDES STRUCTURAL GUIDANCE FOR MANUSCRIPTS, THE ABSTRACT'S CONTENT IS PRIMARILY DICTATED BY THE NATURE OF YOUR RESEARCH. FOR A PSYCHOLOGY DISSERTATION ABSTRACT, CMOS WOULD EXPECT IT TO BE A CONCISE SUMMARY, TYPICALLY BETWEEN 150-350 WORDS, COVERING YOUR RESEARCH PROBLEM OR QUESTION, YOUR METHODOLOGY, YOUR MAIN FINDINGS, AND YOUR CONCLUSIONS OR IMPLICATIONS. THIS ALLOWS READERS TO QUICKLY GRASP THE ESSENCE OF YOUR STUDY.

Q: HOW DOES THE CHICAGO MANUAL OF STYLE ADDRESS THE USE OF HEADINGS AND SUBHEADINGS WITHIN PSYCHOLOGY DISSERTATIONS?

A: CMOS ADVOCATES FOR A CLEAR, HIERARCHICAL STRUCTURE OF HEADINGS AND SUBHEADINGS TO ORGANIZE CONTENT LOGICALLY. IT PROVIDES SPECIFIC RECOMMENDATIONS ON THE FORMATTING (E.G., CAPITALIZATION, PLACEMENT, FONT STYLE) OF DIFFERENT HEADING LEVELS, ENSURING CONSISTENCY AND READABILITY. FOR A PSYCHOLOGY DISSERTATION, THIS HELPS GUIDE THE READER THROUGH COMPLEX SECTIONS LIKE LITERATURE REVIEW, METHODOLOGY, RESULTS, AND DISCUSSION IN A STRUCTURED MANNER.

Q: WHEN CITING QUALITATIVE DATA, SUCH AS INTERVIEW TRANSCRIPTS, IN A PSYCHOLOGY DISSERTATION UNDER THE CHICAGO MANUAL OF STYLE, WHAT ARE THE RECOMMENDED PRACTICES?

A: FOR QUALITATIVE DATA LIKE INTERVIEW TRANSCRIPTS, IF YOU ARE USING THE NOTES-BIBLIOGRAPHY SYSTEM, YOU WOULD TYPICALLY CITE THEM IN FOOTNOTES OR ENDNOTES, PROVIDING DETAILS ABOUT THE INTERVIEW (E.G., INTERVIEWEE, DATE, CONTEXT) AND THE SPECIFIC PORTION BEING QUOTED. IN THE BIBLIOGRAPHY, YOU MIGHT LIST THE COLLECTION OF INTERVIEWS OR A SPECIFIC INTERVIEW IF IT'S A PUBLISHED WORK. IF USING THE AUTHOR-DATE SYSTEM, THE CITATION WOULD BE PARENTHETICAL, REFERENCING THE SOURCE IN YOUR REFERENCE LIST. ENSURING PARTICIPANT ANONYMITY IS PARAMOUNT, SO PSEUDONYMS OR ANONYMIZED IDENTIFIERS SHOULD BE USED CONSISTENTLY.

Q: HOW SHOULD FIGURES OR GRAPHICS FROM EXTERNAL PSYCHOLOGY STUDIES BE INCORPORATED INTO A DISSERTATION FOLLOWING THE CHICAGO MANUAL OF STYLE?

A: WHEN INCORPORATING FIGURES OR GRAPHICS FROM EXTERNAL SOURCES, CMOS REQUIRES THAT YOU OBTAIN NECESSARY PERMISSIONS AND PROVIDE FULL ATTRIBUTION. THE FIGURE SHOULD BE NUMBERED AND HAVE A DESCRIPTIVE CAPTION, AS OUTLINED IN CMOS GUIDELINES FOR FIGURES. CRUCIALLY, THE SOURCE OF THE FIGURE MUST BE CITED WITHIN THE CAPTION OR IN A NOTE, USING THE APPROPRIATE CMOS FORMAT FOR THE ORIGINAL SOURCE (E.G., JOURNAL ARTICLE, BOOK). THIS UPHOLDS ACADEMIC INTEGRITY AND AVOIDS COPYRIGHT INFRINGEMENT.
