First Reference Citations

The initial citation for a source in a footnote or endnote provides complete bibliographic information. Subsequent Reference Citations

After the first full citation, subsequent references to the same source are shortened. This typically involves the author's last name, a shortened version of the title, and the page number. In cases where an author has multiple works cited, or when citing different works by the same author within the same essay, the shortened title becomes even more critical for disambiguation. If only one work by an author is

cited, CMOS allows for even greater brevity, using just the author's last name and page number after the first full citation, though the shortened title is often preferred for clarity.

The Bibliography

The bibliography, appearing at the end of the essay, lists all sources consulted and cited within the text. It is arranged alphabetically by author's last name. Unlike the footnotes or endnotes, the bibliography entries typically do not include page numbers unless a specific section or chapter is being referenced as a whole. The formatting in the bibliography is similar to the first note citation but with a crucial difference: the author's last name is listed first, followed by a comma and their first name. For example:

Author-Date System for Literary Studies

While less traditional in literary scholarship compared to the notes-bibliography system, the author-date system is a viable and increasingly common alternative, particularly in certain academic fields and for specific types of publications. This system uses parenthetical citations within the text, consisting of the author's last name and the year of publication, followed by the page number. In-Text Citations

The inclusion of the year is crucial for distinguishing between different works by the same author published in the same year, and for historical context. When citing multiple works by the same author, or works with the same author and year, the system provides methods for differentiation (e.g., Bell 1991a, Bell 1991b).

The Reference List

The reference list in the author-date system is arranged alphabetically by the author's last name. Each entry provides all necessary information for the reader to locate the source. Unlike the bibliography in the notes system, the publication year immediately follows the author's name. For example:

- Bell, Quentin. *Virginia Woolf: A Biography*. New York: Harcourt Brace Jovanovich, 1991.

This system prioritizes the date of publication, which can be particularly useful for tracking the development of scholarly thought or the evolution of critical interpretations over time. While it may feel less common for purely literary essays, its efficiency for extensive bibliographies and its prevalence in interdisciplinary work make it a valuable option to understand.

The sad thing was the boy believed them. But the old man did not.
(Hemingway 1952, 19)

This clear distinction for extended quotations helps maintain the flow of your essay while giving the quoted material appropriate prominence.

Titles and Headings

While this article uses H2 and H3 tags, a formal Chicago-style essay typically does not use such extensive internal headings unless the assignment specifically requires it. If headings are used, they should be consistent in style and formatting, following CMOS guidelines for capitalization and placement. The main essay title is centered at the top of the first page of text.
