Understanding the Chicago Manual of Style in

In the notes-bibliography system, a superscript number is placed after the relevant passage in the text, corresponding to a footnote or endnote. The first time a source is cited, the note includes the full bibliographic information. Skinner, *Walden Two* (New York: Macmillan, 1948), 123. A subsequent note for the same work would be: 2. Skinner, *Walden Two*, 250.

Crafting the Bibliography or Reference List

The bibliography or reference list is a critical component of any scholarly work. It provides readers with the full details of all sources cited, enabling them to locate and consult these materials themselves. The specific order and formatting of entries vary slightly between the two Chicago systems but share common principles.

For the **notes-bibliography system**, the bibliography is typically arranged alphabetically by author's last name. Entries include author, title, publication information, and often the year. The first line of each entry is flush left, with subsequent lines indented (hanging indent). For example, a book entry might look like:

1971.

For a journal article:

- Bandura, Albert. "Social Learning Through Imitation." Nebraska Symposium on Motivation 17 (1969): 213–69.

For the **author-date system**, the reference list follows similar principles of alphabetical order and hanging indents. The primary difference is the placement of the publication year, which typically follows the author's name. For example, a book entry would be:

- Skinner, B. F. 1971. Beyond Freedom and Dignity. New York: Alfred A. Knopf.

And a journal article:

- Bandura, Albert. 1969. "Social Learning Through Imitation." Nebraska Symposium on Motivation 17: 213–69.

Consistency in formatting across all entries is key to maintaining scholarly rigor.

Formatting Tables and Figures in Psychological Research

The clear and accurate presentation of data through tables and figures is essential in psychology. Chicago style provides specific guidelines to ensure these elements are understandable and integrated seamlessly into the text.

Tables are used to present precise numerical data or detailed comparisons. Each table should have a number (e.g., Table 1) and a descriptive title.
