Understanding the Two Chicago Citation Systems

The Chicago Manual of Style (CMOS) offers two distinct systems for citing sources: the notes-bibliography system and the author-date system. Citing Journal Articles in Notes-Bibliography

Similar to book citations, subsequent notes for the same article use a shortened format: Pollan, "Omnivore's Dilemma," 80. Ensuring accuracy in journal titles, volume, and issue numbers is paramount for correct attribution and ease of retrieval for readers.

Citing Websites in Notes-Bibliography

Citing websites in the notes-bibliography system requires attention to the available information. The Author-Date System: In-Text Citations and Reference Lists

citations that include the author's last name and the year of publication. When quoting or paraphrasing, a page number is also included. These parenthetical citations correspond to a "Reference List" at the end of the document, which contains full bibliographic information for every source cited. Citing Books in Author-Date

In the author-date system, an in-text citation for a book would appear as (AuthorLastName Year, PageNumber). For instance, if you were citing Jane Austen's *Pride and Prejudice*, and referencing page 45, the citation would be (Austen 2003, 45). The corresponding entry in the Reference List would be: Austen, Jane. 2003. *Pride and Prejudice*. New York: Penguin Classics.

The Reference List entry includes the author's last name followed by a comma, then their first initial and name, the publication year in parentheses, the italicized title, and then the place of publication and publisher. This format is consistent for all book citations in the author-date system.

Citing Journal Articles in Author-Date

For journal articles in the author-date system, the in-text citation follows the pattern (AuthorLastName Year, PageNumber). For Michael Pollan's article, an in-text citation might be (Pollan 2004, 80). The Reference List entry would then be: Pollan, Michael. 2004. "The Omnivore's Dilemma." *The New Yorker*, October 25. The page range for the entire article (78-84) is usually provided in the Reference List entry, but the in-text citation directs to the specific page being referenced.

Accuracy in journal titles, volume, and issue numbers is crucial for the author-date system, as it aids readers in locating the specific publication quickly. The Reference List provides the full details for each article cited.

Citing Websites in Author-Date

Citing websites in the author-date system requires a similar approach to other sources. The in-text citation would be (AuthorLastName Year) or (Website Name Year) if no author is specified. If a specific page is referenced, include the page number if available, though website pagination can be less standardized. A typical Reference List entry for a website might look like this: Wikipedia. 2023. "The History of the Internet." Last modified April 10. https://en.wikipedia.org/wiki/History_of_the_Internet.

When citing web content, it's important to provide as much publication or modification information as possible. If no specific date is available, you might use "n.d." for no date, and a retrieval date is often included for web sources that are subject to change.
