Websites and Online Articles

Citing online sources requires careful attention to details like the website name, author (if available), title of the specific page or article, publication date (if available), and the URL. Including an access date is highly recommended for online sources, as web content can change.

Chapters in Edited Books

When referencing a chapter written by one author within an edited book by another, you must cite both the chapter author and the book editor. The note will specify the chapter author and title, followed by the book title, editor, publication details, and the chapter's page range.

Interviews

Interviews, whether published or conducted personally, require careful citation. If the interview has been published, cite it as a published work. For unpublished interviews, provide details about the interviewee, the interviewer, the date, and the medium of the interview.

Formatting Guidelines for Notes and Bibliography

Consistent formatting is paramount in Chicago style. Beyond the order of information, specific punctuation, capitalization, and indentation rules contribute to the professional appearance of your short paper. Pay close attention to these details to ensure accuracy and adherence to the manual.

For notes (footnotes or endnotes), the first line of each note is typically indented, with subsequent lines of the same note aligned with the left margin. For the bibliography, a hanging indent is used: the first line of each entry is flush with the left margin, and subsequent lines are indented. This format aids in distinguishing individual entries within the list.

Punctuation, such as commas, periods, and parentheses, must be placed precisely as indicated in CMOS examples. Titles of books and journals are italicized, while titles of articles, chapters, and essays are enclosed in quotation marks. The use of abbreviations for publishers and places of publication should follow CMOS guidelines, though for short papers, writing them out fully is often acceptable if not specified otherwise by an instructor.
