Understanding the Chicago Manual of Style for Theses

For example, a first note for a book might appear as:

1. Michel Foucault, *Discipline and Punish: The Birth of the Prison* (New York: Vintage Books, 1995), 23.

A subsequent note for the same book would be:

2. Foucault, *Discipline and Punish*, 145.

It is essential to consult the latest edition of *The Chicago Manual of Style* for precise formatting of commas, periods, and other punctuation within your notes.

Crafting Your Bibliography

The bibliography, appearing at the end of your thesis, provides a comprehensive alphabetical list of all the sources you have cited in your notes. Unlike the notes, which can include detailed commentary, the bibliography entries are strictly bibliographic information. Each entry should contain all the details necessary for a reader to identify and locate the source independently. The purpose of the bibliography is to offer a clear, organized, and complete overview of the research materials consulted.

The ordering of elements in a bibliography entry differs slightly from a note. For instance, author names are inverted (Last Name, First Name), and titles are typically followed by publication information without being enclosed in parentheses. For a book, the standard format in the

bibliography would be:

Foucault, Michel. *Discipline and Punish: The Birth of the Prison*. New York: Vintage Books, 1995.

Consistency in formatting all bibliography entries is paramount to the overall professionalism of your thesis.

Common Source Types and CMOS Examples

Academic theses often draw from a diverse range of sources, from classic books and scholarly journal articles to more contemporary digital resources. Mastering the CMOS formatting for each type is critical. Below are examples of common source types and their Chicago notes-and-bibliography format.

Books

For a single-author book, both in notes and bibliography, the essential information includes author, title, place of publication, publisher, and year. For notes, include the page number referenced. For the bibliography, omit the page number and invert the author's name.

- **Note Example:** 3. Edward Said, *Orientalism* (New York: Pantheon Books, 1978), 72.
- **Bibliography Example:** Said, Edward. *Orientalism*. New York: Pantheon Books, 1978.

Journal Articles

Citing journal articles requires specific details, including author, article title, journal title, volume and issue numbers, and publication year, along with page numbers. In notes, you will also include the specific page being cited.

- **Note Example:** 4. Gayatri Chakravorty Spivak, "Can the Subaltern Speak?" in *Marxism and the Interpretation of Culture*, ed. Cary Nelson and Lawrence Grossberg (Urbana: University of Illinois Press, 1988), 271.
- **Bibliography Example:** Spivak, Gayatri Chakravorty. "Can the Subaltern Speak?" In *Marxism and the Interpretation of Culture*, edited by Cary Nelson and Lawrence Grossberg, 271-313. Urbana: University of Illinois Press, 1988.

Websites and Online Resources

Citing online sources requires careful attention to the URL, access date, and any information that can help readers find the specific content. CMOS emphasizes providing as much information as possible for retrieval.

- **Note Example:** 5. "History of the Chicago Manual of Style," The University of Chicago Press, accessed October 26, 2023, <https://www.chicagomanualofstyle.org/about.html>.
- **Bibliography Example:** "History of the Chicago Manual of Style." The University of Chicago Press. Accessed October 26, 2023. <https://www.chicagomanualofstyle.org/about.html>.

Author-Date System: An Alternative Approach

While the notes-and-bibliography system is prevalent in the humanities, the author-date system is more common in the sciences and social sciences. In this system, in-text citations consist of the author's last name and the year of publication, often including the page number. A corresponding reference list is provided at the end, which includes full bibliographic details for all cited works. The fundamental difference lies in the in-text attribution; instead of numerical notes, parenthetical citations directly reference the author and date.

For instance, a parenthetical citation in the author-date system would look like (Foucault 1995, 23). The reference list entries would still maintain a similar structure to the bibliography in the notes-and-bibliography system, but the overall presentation of citations within the text is altered. For a thesis, choosing the appropriate system is typically dictated by departmental or disciplinary guidelines.
