Specific sections or chapters within the report can be cited by including chapter or section titles and page numbers.

Q: How does CMOS address the issue of presenting potentially ambiguous chronological periods in US prehistory?

A: CMOS advocates for clarity and precision when discussing chronological periods. Researchers should indicate the specific dating methods used and any associated margins of error. For periods with known ambiguity or differing scholarly interpretations, CMOS suggests presenting these variations clearly, attributing each interpretation to its source, and explaining the evidence or reasoning behind them. This transparency helps readers understand the limitations of dating evidence.
