Understanding Direct vs. Indirect Quotations

To format a block quotation, indent the entire passage five spaces (or 0.5 inches) from the left margin. The first line of the block quotation is indented the same as the subsequent lines. Double-spacing is typically maintained within the block quotation, mirroring the main text's spacing. No quotation marks are used to enclose the block itself, as the indentation serves this purpose.

Punctuation and Attribution for Block Quotes

Punctuation within a block quotation remains as it appears in the original source.
