## Websites and Online Sources

Citing online sources, such as webpages and articles from online publications, requires careful attention to author (if available), title of the specific page or article, name of the website, publication date (if available), and the URL. For the Notes-Bibliography system, notes will often include the author, title, website name, publication date, and URL. If no author is listed, the title of the page or article begins the entry. Bibliography entries will also include an access date for webpages. In the Author-Date system, the in-text citation will be (Author Last Name Year, Page Number), if a page number is applicable, or just (Author Last Name Year).
