IT HELPS IN REFINING RESEARCH OBJECTIVES, IDENTIFYING POTENTIAL CHALLENGES, AND ANTICIPATING THE RESOURCES REQUIRED. FOR ACADEMIC INSTITUTIONS, IT FUNCTIONS AS A QUALITY CONTROL MECHANISM, ENSURING THAT RESEARCH UNDERTAKEN MEETS ETHICAL STANDARDS AND CONTRIBUTES MEANINGFULLY TO THE ACADEMIC DISCOURSE. DEFINING THE RESEARCH PROBLEM AND QUESTIONS

THE HEART OF ANY RESEARCH PROPOSAL LIES IN ITS CLEARLY DEFINED RESEARCH PROBLEM AND SUBSEQUENT RESEARCH QUESTIONS.
