Each entry in the bibliography corresponds to an in-text citation and provides full publication details. The format of these entries varies depending on the type of source (book, article, website, etc.). The bibliography entry in the author-date system for a book typically maintains a similar structure but might omit the publisher's city in some contexts, though CMS generally retains it. The key difference is the in-text parenthetical citation.

Chicago Manual Paraphrase Citation Examples: Websites

Citing web content requires careful attention to available information. When paraphrasing from a website, include the author (if known), the title of the specific page or article, the website's name, and the URL. For dated content, include the publication or last updated date. In the notes-bibliography system, the note should include this information along with the access date if the content might change.

For the author-date system, the in-text citation would typically omit the URL and access date in the parenthetical citation itself, but these are included in the reference list.

driven by both technological advancements and supportive government policies (Global Energy Institute 2023).
