UPHOLDING INTEGRITY IN ACADEMIC WRITING

UNDERSTANDING ACADEMIC DISHONESTY WITHIN THE CMOS FRAMEWORK

ACADEMIC DISHONESTY ENCOMPASSES A RANGE OF UNETHICAL BEHAVIORS THAT UNDERMINE THE PRINCIPLES OF SCHOLARLY INQUIRY AND FAIR EVALUATION. BOTH ARE DESIGNED TO ENSURE THAT READERS CAN EASILY IDENTIFY THE ORIGIN OF INFORMATION, THUS PREVENTING THE MISREPRESENTATION OF ANOTHER'S WORK AS ONE'S OWN. WHEN ENGAGING WITH ACADEMIC WRITING, PARTICULARLY WHEN DRAWING UPON EXISTING SCHOLARSHIP, STUDENTS AND RESEARCHERS ARE OBLIGATED TO UNDERSTAND AND IMPLEMENT THESE CITATION METHODS CORRECTLY TO SAFEGUARD THEIR ACADEMIC REPUTATION.

FORMS OF ACADEMIC DISHONESTY TO AVOID

ACADEMIC DISHONESTY MANIFESTS IN VARIOUS INSIDIOUS FORMS, ALL OF WHICH ERODE THE FOUNDATION OF TRUST AND LEARNING WITHIN ACADEMIC INSTITUTIONS. RECOGNIZING THESE FORMS IS THE FIRST STEP TOWARD PREVENTING THEM. PLAGIARISM, THE MOST COMMON ACCUSATION, INVOLVES PRESENTING SOMEONE ELSE'S IDEAS, WORDS, OR WORK AS YOUR OWN WITHOUT PROPER ATTRIBUTION. THIS CAN RANGE FROM DIRECT COPYING OF TEXT TO PARAPHRASING WITHOUT CITATION OR EVEN STEALING THE STRUCTURE OF AN ARGUMENT.

OTHER SIGNIFICANT FORMS OF ACADEMIC DISHONESTY INCLUDE:

- **CHEATING ON EXAMINATIONS OR ASSIGNMENTS:** THIS INCLUDES COPYING ANSWERS FROM PEERS, USING UNAUTHORIZED

MATERIALS DURING TESTS, OR SUBMITTING WORK COMPLETED BY SOMEONE ELSE.

- **FABRICATING DATA OR RESULTS:** CREATING FALSE INFORMATION OR MISREPRESENTING RESEARCH FINDINGS IS A SEVERE BREACH OF ACADEMIC INTEGRITY.
- **COLLUSION:** WORKING WITH OTHERS ON AN ASSIGNMENT WHEN INDIVIDUAL WORK IS EXPECTED, WITHOUT PROPER ACKNOWLEDGMENT OF SHARED EFFORT.
- **CONTRACT CHEATING:** PAYING OR HIRING SOMEONE TO COMPLETE AN ASSIGNMENT OR PAPER ON YOUR BEHALF.
- **SELF-PLAGIARISM:** REUSING ONE'S OWN PREVIOUSLY SUBMITTED WORK WITHOUT PROPER ACKNOWLEDGMENT OR PERMISSION, ESPECIALLY IF IT IS PRESENTED AS NEW WORK.

EACH OF THESE ACTIONS DIRECTLY CONTRAVENES THE PRINCIPLES OF GENUINE SCHOLARSHIP AND INTELLECTUAL HONESTY. THE CHICAGO MANUAL OF STYLE'S RIGOROUS CITATION REQUIREMENTS ARE DESIGNED, IN PART, TO HELP WRITERS AVOID THE MOST PREVALENT FORM OF ACADEMIC DISHONESTY: PLAGIARISM.

THE ROLE OF CHICAGO MANUAL STYLE IN PREVENTING PLAGIARISM

THE CHICAGO MANUAL OF STYLE (CMOS) PLAYS A PIVOTAL ROLE IN ACADEMIC INTEGRITY BY PROVIDING A COMPREHENSIVE AND UNAMBIGUOUS SYSTEM FOR ATTRIBUTING SOURCES. A: CONSEQUENCES CAN RANGE FROM FAILING GRADES ON ASSIGNMENTS OR COURSES TO SUSPENSION OR EXPULSION FROM ACADEMIC INSTITUTIONS, AND SIGNIFICANT DAMAGE TO ONE'S ACADEMIC AND PROFESSIONAL REPUTATION.

Q: CAN THE CHICAGO MANUAL OF STYLE HELP DISTINGUISH BETWEEN COMMON KNOWLEDGE AND INFORMATION THAT REQUIRES CITATION?

A: YES, CMOS, LIKE OTHER STYLE GUIDES, IMPLIES AN UNDERSTANDING OF WHAT CONSTITUTES COMMON KNOWLEDGE, WHICH GENERALLY DOES NOT REQUIRE CITATION. HOWEVER, IT STRONGLY ADVISES ERRING ON THE SIDE OF CAUTION AND CITING ANY INFORMATION THAT IS NOT UNIVERSALLY KNOWN OR DIRECTLY OBSERVABLE.

Q: IS SELF-PLAGIARISM CONSIDERED A FORM OF ACADEMIC DISHONESTY ACCORDING TO THE PRINCIPLES SUPPORTED BY THE CHICAGO MANUAL OF STYLE?

A: YES, SELF-PLAGIARISM, WHICH INVOLVES REUSING ONE'S OWN PREVIOUS WORK WITHOUT PROPER ACKNOWLEDGMENT, IS A FORM OF ACADEMIC DISHONESTY. THE PRINCIPLES OF FULL ATTRIBUTION THAT CMOS PROMOTES EXTEND TO ENSURING THAT PREVIOUSLY PUBLISHED OR SUBMITTED WORK IS CLEARLY IDENTIFIED.
