The Fundamentals of Chicago Style Author-Date

The Chicago Manual of Style (CMOS) offers two distinct citation systems: Notes-Bibliography and Author-Date. For three or more editors, use commas and "and" before the last editor's name. The format for the editor portion is "edited by Editor1 First Last, Editor2 First Last, and Editor3 First Last."

Including Page Numbers for the Entire Work (Optional but Recommended)

While not strictly mandatory for every author-date citation in Chicago style when citing a chapter, it is good practice to include the total page count of the anthology if known, especially if the chapter's page range is extensive. This provides additional context about the size of the overall collection. The format for this would be "Page range of chapter, pp. Total Pages." For example: "100-125, pp. 350."

Citing an Entire Anthology

Citing Works with Original Publication Dates

Many anthologies include works that were originally published much earlier. If the original publication date is relevant to your argument, you can include it. The in-text citation would then be (Author Last Name Year of Anthology, Original Year, Page Number). The reference list entry would also reflect this:

Author Last Name, First Name. Original Year. "Title of Chapter/Essay." In *Title of Anthology*, edited by Editor First Name Last Name, Page range of chapter. Year of Anthology. City of Publication: Publisher.

Example: Smith, John. 1955. "The City as Organism." In *Modern Cityscapes: A Collection of Essays*, edited by Sarah Lee, 20-35. 2022. New York: Academic Press.

Citing Forewords, Introductions, or Prefaces

These introductory sections are often written by someone other than the primary editor or contributors. Cite them by the author of the foreword/introduction, using the same principles as citing a chapter. The title of the foreword/introduction should be in quotation marks.

Navigating Common Challenges in Anthology Citations

Working with anthologies can present unique citation challenges. Being aware of these potential pitfalls and knowing how to address them will ensure your Chicago author-date citations are accurate and consistent.

Missing Publication Information

Occasionally, you might encounter an anthology with incomplete publication details, such as a

missing publisher or publication year. In such cases, use "n.d." for "no date" and "n.p." for "no place" or "no publisher" as appropriate. For example, (Doe n.d.) or [City of Publication]: [Publisher] n.p.

Works by the Same Author in the Same Year

If you cite multiple works by the same author published in the same year, you must differentiate them by adding lowercase letters (a, b, c) to the year in both the in-text citations and the reference list. For example, (Smith 2021a) and (Smith 2021b). The reference list would order these alphabetically by title.

Anthologies with Very Similar Titles

If your anthology is one of several with very similar titles, ensure your reference list entries are as detailed as possible, including editors and publishers, to avoid confusion. The author-date system relies heavily on the clarity of these differentiating details.

Q: What is the correct way to format the title of a chapter or essay within an anthology in the reference list?

A: Titles of individual chapters, essays, or other shorter works within an anthology are placed in quotation marks in the reference list. The title of the anthology itself, however, should be italicized. For example: "The Art of Storytelling." In *Narrative Structures*.
