Understanding the Chicago Style Author-Date System

The Chicago Manual of Style (CMOS) offers two primary citation systems: notes and bibliography, and author-date. For digital video, the author-date system is often preferred in fields where brief in-text citations are conducive to the flow of discussion, particularly in social sciences and natural sciences. This system requires a parenthetical in-text citation that includes the author's last name and the year of publication, or a relevant descriptor if a specific author or year is unavailable. When encountering a citation within the text, the reader can quickly locate the corresponding full citation in the reference list without needing to scan footnotes or endnotes. The core principle is to provide enough information for the reader to identify and retrieve the source reliably, even with the ephemeral nature of some online content.

Core Components of a Digital Video Citation

This title should be the official title as it appears on the video or its hosting platform. For YouTube videos, this is often the title that appears in the browser tab and on the video's page. Ensure that any capitalization or special characters in the title are replicated accurately.

Platform or Publisher

Indicating the platform where the video is hosted is vital for directing the reader to the source. This could be YouTube, Vimeo, a university's digital repository, or another online service. If a specific publisher or distributor is identifiable beyond the platform itself (e.g., a production company for a documentary hosted on YouTube), this can also be included. For many web videos, the platform itself serves as the primary publisher identifier.

URL or Persistent Identifier

The Uniform Resource Locator (URL) is the web address that allows direct access to the digital video. This should be the full and specific URL of the video page. In academic contexts, if a Digital Object Identifier (DOI) or other persistent identifier is available for the video, it should be used in place of or in addition to the URL, as these are more stable and reliable. Ensure the URL is current and functional at the time of writing.

Vimeo Videos

Similar to YouTube, Vimeo videos require identification of the creator, title, year, platform, and URL. The creator might be an individual or a company. The title should be italicized. For instance: National Geographic. 2021. *Great White Shark Migration*. Vimeo. <https://vimeo.com/587654321>.

Academic Lectures and Presentations

When citing recorded academic lectures or presentations, the author is usually the speaker or presenter. The title of the lecture should be italicized. The year of recording or upload is crucial. If the lecture is part of a larger course or event, this context may also be included. For example: Smith, John. 2023. *Introduction to Quantum Mechanics*. Recorded at University of Chicago, September 15, 2023. https://university.edu/lectures/smith/quantum_intro.

Documentaries and Feature Films (Online)

When citing documentaries or feature films available online through streaming services or for purchase, the citation format closely follows that of a traditional film citation but includes the online access information. The director is often cited as the author. The title is italicized, followed by the year of release, the production company, and then the platform and URL if accessed online. For example: Attenborough, David, dir. 2019. *Our Planet: Jungles*. Netflix. <https://www.netflix.com/title/80995714>.

Web Series Episodes

For individual episodes of web series, the episode title is typically cited as the main title, often italicized. The series title might be mentioned as context. The creator of the series or episode, the year, the platform, and the URL are then provided. For example: WNYC Studios. 2021. "Episode 1: The First Wave." *The Daily*. Accessed October 26, 2023.

Best Practices for Digital Video Citations

Adhering to best practices ensures clarity, consistency, and academic rigor when citing digital videos. These guidelines help to navigate the dynamic nature of online content and provide reliable information to your readers.

Be Specific and Accurate

Always strive for the most specific information available. If a video has an individual creator, use their name. If a precise publication date is listed, use it in the in-text citation if it differs significantly from the upload date and is relevant to your argument. Double-check all titles, dates, and URLs for accuracy.

Use a Consistent Format

Once you establish a format for citing a particular type of digital video, maintain that consistency throughout your work. This uniformity makes your reference list easier to read and understand.

Provide Access Information

The URL is critical, but also consider if a more stable identifier like a DOI is available. If the video is behind a paywall or requires registration, note that if it is relevant to accessibility for your readers. For institutional videos, mention the repository or archive.

Consider the Audience

If you are writing for a specific academic discipline, consult its particular citation conventions. While Chicago style is a robust framework, some fields may have minor adaptations or preferences for digital media citation.

Archive or Note Stability

Changes to Video Content or Metadata

If a video you have cited is later updated or has its metadata changed (e.g., title, description), it's best practice to cite the version you originally accessed. If the changes are significant and alter the core content or attribution, you might need to re-evaluate your source or note the discrepancy.

Videos Embedded from Other Platforms

If a video is embedded on one website but originates from another platform (like a YouTube video embedded on a news site), cite the original platform and creator. The embedding website is generally not considered the publisher unless it has independently created or significantly curated the content. Focus on the source of the video itself.
