Understanding the Chicago Style Author-Date System

Websites and Online Sources

If no author is listed, you may use a shortened version of the website or organization name followed by the year (e.g., (National Institute of Health 2021)). Page numbers are typically not used for web content unless specific pagination is provided.

The reference list entry for a website should include the author (or organization name), the title of the specific page or article, the website name, the publication date (or last updated date), and the URL. If a publication date is unavailable, use "n.d." for "no date."

Constructing the Reference List

Alphabetical Ordering

For works by the same author, entries are arranged chronologically by publication year, from earliest to latest. If there are multiple works by the same author in the same year, they are distinguished by adding lowercase letters after the year (e.g., 2020a, 2020b).

It is a fundamental aspect of academic convention that aids in the efficient navigation and verification of cited materials. Maintaining alphabetical order is as crucial as the accuracy of the individual bibliographic details.

- Reference list (four or more authors): Kim, Sung-Ho, Anya Sharma, Ben Carter, and Emily Davies. 2023. Another Title. Publisher. (Note: CMOS might prefer listing only Kim et al. here, check the latest edition).

Citing Sources with No Date

Occasionally, you will encounter sources that lack a publication date. In such instances, the abbreviation "n.d." (for "no date") is used in place of the year. This applies to both in-text citations and the reference list.
