Step 7: Create In-Text Citations

Articles Without Specific Publication Dates

If an online magazine article does not provide a specific publication date, you may use the

date of access. This indicates when you last viewed the content. However, always strive to find the original publication date first, as it is more informative.

Online-Only Articles

Many articles are created specifically for online publication and may not have a print counterpart. The citation format remains largely the same, emphasizing the URL as the primary access point. It's important to note if the article is an online-only feature, though it doesn't typically alter the core citation structure itself beyond providing the URL.
