For videos on platforms like YouTube, the uploader or credited creator is often the author. The year is the year of upload. It is crucial to include the URL and the date you accessed the video.

- Creator Last Name, First Name, or Uploader Name. Year. "Title of Video." Type of recording. Platform Name. Month Day, Year accessed. URL.

Example: National Geographic. 2021. "Amazing Animals: The Arctic Fox." Documentary. YouTube. October 27, 2023. <https://www.youtube.com/watch?v=xxxxxxx>.

Handling Corporate or Institutional Videos

Common Pitfalls and How to Avoid Them
