Edited Books

For edited books, the editor's name(s) replace the author's name in the citation. The editor's role is indicated by "ed." for one editor or "eds." for multiple editors. This distinguishes it from a work authored by the named individuals.

Parenthetical Citation: (Anderson, ed. 2018)

Reference List Entry: Anderson, Samuel, ed. 2018. *Readings in Literary Criticism*. New York: Oxford

University Press.

Articles in Periodicals (Journals and Magazines)

Journal articles are cited with the author's name, publication year, article title in quotation marks, journal title in italics, volume and issue numbers, and the page range. Magazine articles follow a similar pattern but usually include the magazine's name and the specific date of publication.

Online Articles

Online articles require a URL and often a retrieval date, especially if the content is likely to change. The core citation elements remain similar to print articles.

Reference List Entry: Garcia, Elena. 2021. "The Future of Artificial Intelligence." *Tech Insights Online*, November 10, 2021. Accessed January 5, 2024. <https://www.techinsights.com/future-ai>.

Websites and Webpages

When citing an entire website or a specific webpage, you typically include the author or organization name, the title of the specific page (if applicable), the website name, the publication date or last

updated date, and the URL. If no author is apparent, use the organization's name or a shortened title.

Other Common Source Types
