Understanding the Chicago Manual of Style for Dissertations

The Chicago Manual of Style (CMOS) is a widely respected citation style in humanities and social sciences, offering two primary systems for referencing: the notes-bibliography system and the author-date system. The Author-Date System: In-Text Citations and Reference List Entries

In the author-date system, in-text citations are brief and enclosed in parentheses, usually containing the author's last name and the year of publication. Page numbers are often included for direct quotations. Chicago Style Bibliography Examples: Websites and Online Resources

The internet has become a vast repository of information. Citing websites requires careful attention to details like author, page title, website name, publication date (if available), and the URL.

Web Page with an Author

When a specific author is credited for a web page.

Chicago Style Bibliography Examples: Other Common Sources

Dissertations often draw upon a variety of sources beyond books and articles, such as dissertations, theses, conference proceedings, and interviews.

Dissertation or Thesis

When citing a previously completed dissertation or thesis.

Formatting Your Dissertation Bibliography

The presentation of your bibliography or reference list is as important as the accuracy of its contents. Proper formatting ensures professionalism and readability.

Alphabetical Order

All entries in the bibliography must be arranged in alphabetical order by the author's last name. If a source has no author, it is alphabetized by the first significant word of the title.

Indentation and Spacing

Typically, the first line of each entry is flush left, and subsequent lines are indented (a hanging indent). Double-spacing is often preferred within and between entries, though this can vary by institutional guidelines.
