- **Bibliography Example (Four+ Authors):** Johnson, Robert, Emily White, Charles Green, and Maria Garcia. *Global Economic Trends*. New Delhi: Sage Publications, 2017.

Books with No Author

If a book has no named author, the citation begins with the title of the book. The title is italicized and treated as the first element of the citation.

- **Note Example:** *The Chicago Reader's Guide to Local Cuisine* (Chicago: Field Guide Press, 2015), 67.
- **Bibliography Example:** *The Chicago Reader's Guide to Local Cuisine*. Chicago: Field Guide Press, 2015.

Multi-Volume Works

When citing a specific volume of a multi-volume work, include the volume number in the citation. For a general reference to the entire set, you can mention the total number of volumes in the bibliography.
