For the notes-bibliography system, the superscript number directly links to a footnote or endnote. For instance, in a political science text, a statement might end with a superscript number¹ that leads to a note containing the citation. The first note for a book might read: 1. David Easton, *The Political System: An Inquiry into the State of Political Science* (Chicago: University of Chicago Press, 1953), 75. Subsequent notes for the same source would be shortened, for example: 2. Easton, *Political System*, 102.

Building a Comprehensive Reference List or Bibliography

The reference list (for author-date) or bibliography (for notes-bibliography) is a critical component of any Chicago style social science book. It serves as a roadmap for readers to explore the sources that informed the author's research. Both lists are alphabetized by the author's last name.
