The Two Systems of Chicago Style Citation

While the exact order and punctuation may vary slightly between the notes-bibliography and author-date systems, these core elements are consistently present.

Author's Name

For books and articles, the author's name is typically the starting point of a bibliography entry. In the notes-bibliography system, the author's last name appears first, followed by their first name. For example, "Smith, John." In the author-date system, the order is usually first name then last name, "John Smith." If there are multiple authors, specific rules apply to how their names are listed.

Title of the Work

The title of the work being cited is a crucial identifier. For books, the full title is italicized. Page Numbers (when applicable)

While page numbers are primarily used within footnotes and endnotes (or parenthetical citations), they may also appear in a bibliography entry for specific types of sources or when referring to a particular section. For example, if you are citing a specific essay within a larger collection, the page range for that essay would be included in the bibliography entry.

Books

More Than Three Authors Book

For books with more than three authors, list the first author followed by "et al." (and others).

- Bibliography: Lastname, Firstname, Firstname Lastname, Firstname Lastname, et al. *Title of Book*. City of Publication: Publisher, Year.
- Example: Garcia, Maria, David Lee, Sophia Chen, et al. *Global Economic Trends*. London: Sterling Publishing, 2019.

Edited Book

When citing a book that has been edited rather than authored, the editor's name is used in place of the author's.

- Bibliography: Editor, Firstname Lastname, ed. *Title of Book*. City of Publication: Publisher, Year.
- Example: Miller, Sarah, ed. *Readings in American Literature*. Boston: Ginn and Company, 2017.

Book with an Editor and Author

If a book has both an author and an editor (e.g., a collection of a single author's letters), list both.

- Bibliography: Author, Firstname Lastname. *Title of Book*. Edited by Firstname Lastname. City of Publication: Publisher, Year.

- Example: Thoreau, Henry David. *The Essential Thoreau*. Edited by Lawrence Buell. New York: Modern Library, 2006.

Chapter in an Edited Book

This citation includes the chapter author, the chapter title, and details of the overall edited book.

- Bibliography: Author, Firstname Lastname. "Title of Chapter." In *Title of Book*, edited by Editor Firstname Lastname, Page range of chapter. City of Publication: Publisher, Year.
- Example: Davis, Emily. "The Social Impact of Technology." In *Digital Futures*, edited by Robert Johnson, 112-135. San Francisco: Tech Press, 2021.

Introduction or Foreword by Someone Other Than the Author

If you are citing material written by someone other than the main author, such as an introduction or foreword, you cite that individual.

- Bibliography: Writer, Firstname Lastname. "Title of Introduction or Foreword." In *Title of Book*, by Author Firstname Lastname, Page range of introduction/foreword. City of Publication: Publisher, Year.
- Example: Walker, David. "A New Perspective." In *Rediscovering Ancient Civilizations*, by Sarah Chen, vii-xv. New York: Historical Publications, 2015.

Journal Articles

Journal articles are critical for contemporary research. The formatting depends on whether it's a print or online source.

Print Journal Article

- Bibliography: Author, Firstname Lastname. "Title of Article." *Title of Journal* Volume, no. Issue (Year): Page range of article.
- Example: Lee, Min. "The Evolution of Renewable Energy." *Journal of Environmental Studies* 25, no.

3 (2022): 45-62.

Online Journal Article

For online articles, include the DOI (Digital Object Identifier) if available, or the URL and retrieval date.

- Bibliography: Author, Firstname Lastname. "Title of Article." *Title of Journal* Volume, no. Issue (Year): Page range of article. DOI: [DOI number]. OR Accessed Month Day, Year. [URL].
- Example: Chen, Wei. "Advances in Artificial Intelligence." *International Journal of Computer Science* 10, no. 1 (2023): 1-15. DOI: 10.1002/ijcs.2023001.
- Example (without DOI): Rodriguez, Maria. "The Impact of Social Media on Politics." *Political Science Quarterly* 38, no. 4 (2021): 110-128. Accessed November 15, 2023.

Websites and Online Resources

Citing online content requires careful attention to attribution, titles, and access information.

Web Page

Cite individual web pages as you would a standalone publication.

- Bibliography: Author, Firstname Lastname (if known). "Title of Web Page." Name of Website. Last modified Month Day, Year (if available). Accessed Month Day, Year. URL.
- Example: National Aeronautics and Space Administration. "Mars Exploration Program." NASA. Last modified October 26, 2023. Accessed November 16, 2023. <https://mars.nasa.gov/program>.
- Example (no author): "Climate Change Projections." Intergovernmental Panel on Climate Change. Last modified October 10, 2023. Accessed November 16, 2023. <https://www.ipcc.ch/projections>.

Entire Website

When citing the website as a whole, provide the organization responsible and the URL.

- Bibliography: Name of Organization. *Title of Website*. Last updated Month Day, Year (if available). Accessed Month Day, Year. URL.
- Example: The Metropolitan Museum of Art. *The Met Collection Online*. Accessed November 16, 2023. <https://www.metmuseum.org/art/collection>.

Other Common Sources

Beyond books and journals, many other source types are common in academic work.

Newspaper Article

- Bibliography: Author, Firstname Lastname. "Title of Article." *Name of Newspaper*, Month Day, Year. Page numbers (if applicable).
- Example: Johnson, Robert. "New Regulations Affecting Small Businesses." *The Wall Street Journal*, November 15, 2023. A1.

Magazine Article

- Bibliography: Author, Firstname Lastname. "Title of Article." *Name of Magazine*, Month Year, Page numbers.
- Example: Garcia, Isabella. "The Future of Space Travel." *National Geographic*, October 2023, 55-68.

Dissertation or Thesis

Include information about the institution and access method if it's an unpublished or online work.

- Bibliography: Author, Firstname Lastname. "Title of Dissertation/Thesis." PhD diss. or MA thesis, University Name, Year.
- Example: Chen, Li. "The Impact of Globalization on Local Economies." PhD diss., University of California, Berkeley, 2019.

- Example (online): Brown, Emily. "Literary Representations of Urban Life." PhD diss., Harvard University, 2020. ProQuest Dissertations Publishing. <https://www.proquest.com/dissertations/>.

Conference Paper

Provide details of the conference where the paper was presented.

- Bibliography: Author, Firstname Lastname. "Title of Paper." Paper presented at the Name of Conference, Location, Month Day, Year.
- Example: Kim, Ji-hoon. "Sustainable Urban Planning." Paper presented at the International Conference on Urban Development, Seoul, South Korea, July 10, 2022.

Film or Television Episode

Cite films and television episodes with their directors and production companies.

- Bibliography: Title of Film. Directed by Firstname Lastname. Production Company, Year.
- Example: Parasite. Directed by Bong Joon-ho. CJ Entertainment, 2019.
- Bibliography: "Title of Episode." *Title of Series*. Directed by Firstname Lastname. Network, Year.
- Example: "The Battle of Winterfell." Game of Thrones. Directed by Miguel Sapochnik. HBO, 2019.

Formatting and General Guidelines for Your Bibliography

Beyond the individual entry formats, overarching principles govern the presentation of your entire Chicago style bibliography.

Alphabetical Order

All entries in your bibliography must be arranged alphabetically by the author's last name. If a source has no author, alphabetize it by the first significant word of its title (ignoring articles like "a," "an," and "the").

Hanging Indent

Chicago style mandates the use of a hanging indent for bibliography entries. This means the first line of each entry is flush with the left margin, and all subsequent lines of that entry are indented (typically by 0.5 inches).

Punctuation and Capitalization

Pay close attention to punctuation and capitalization as specified by Chicago style. Commas, periods, colons, and parentheses have specific placements that are crucial for clarity and adherence to the style guide. Titles of books and journals are italicized, while titles of articles and chapters are in quotation marks.

Consistency is Key
