Understanding the Two Chicago Style Systems

The Chicago Manual of Style (CMOS) offers two primary citation systems: the notes-bibliography system and the author-date system. Both are designed to provide clear and consistent referencing, but they differ in their application and structure. The notes-bibliography system, often preferred in disciplines like history, literature, and art, uses footnotes or endnotes to cite sources and includes a bibliography at the end of the work. The author-date system, more common in the social sciences and some natural sciences,

uses parenthetical in-text citations and a reference list at the end of the document. While the core information required for a citation remains similar, the placement and formatting vary significantly between these two approaches. It is crucial to identify which system your instructor or publisher requires. Using the incorrect system can lead to a deduction of points or rejection of your manuscript. Familiarizing yourself with the fundamental differences will prevent confusion and ensure you are applying the correct rules to your academic or professional writing. Chicago Notes-Bibliography System: Book Citations

The notes-bibliography system employs numbered notes (footnotes or endnotes) to cite sources within the text. These notes provide detailed information about the source the first time it is referenced, and shorter versions are used for subsequent citations of the same work. Following the notes, a comprehensive bibliography lists all sources cited in the paper, alphabetized by author's last name.

Full Note for a Book: Chicago Style

The first time a book is cited in a note, it requires a full bibliographic entry. This provides complete information for the reader to locate the source easily. The punctuation and order of elements are critical for accuracy.

- **Format:** First Name Last Name, *Book Title* (City of Publication: Publisher, Year of Publication), Page Number(s).

For example, a full note for a book by a single author would look like this:

1. Jane Doe, *The History of Chicago* (Chicago: University of Chicago Press, 2022), 45.

Subsequent Note for a Book: Chicago Style

For any subsequent citations of the same book within the same paper, a shortened note format is used. This saves space and avoids redundancy, assuming the reader has already encountered the full citation. If multiple works by the same author are cited, the shortened note must include a shortened title.

- **Format:** Last Name, *Shortened Book Title*, Page Number(s).

Following the previous example, a subsequent note would be:

2. Doe, *History of Chicago*, 112.

If you were citing another book by Jane Doe, say *Chicago Architecture*, the subsequent note would need to differentiate:

3. Doe, *History of Chicago*, 201.

4. Doe, *Chicago Architecture*, 34.

Bibliography Entry for a Book: Chicago Style

The bibliography is an alphabetized list of all sources used in your paper. Unlike notes, the author's last name comes first, and the publication information is presented in a slightly different order and format. It serves as a comprehensive reference for your readers.

- **Format:** Last Name, First Name. *Book Title*. City of Publication: Publisher, Year of Publication.

The bibliography entry corresponding to the previous examples would be:

Doe, Jane. *The History of Chicago*. Chicago: University of Chicago Press, 2022.

Chicago Author-Date System: Book Citations

The author-date system, as its name suggests, integrates citation information directly into the text through parenthetical references. These typically include the author's last name and the year of publication, and often the page number. The corresponding reference list at the end of the paper provides full bibliographic details for each source.

In-Text Citation for a Book: Chicago Style

In-text citations are placed within the body of your text, usually at the end of a sentence or clause that contains information drawn from a source. They are brief and direct the reader to the full entry in the reference list.

- **Format:** (Author Last Name Year, Page Number)

For a book by Jane Doe, an in-text citation would appear like this:

The historical development of the city is well-documented (Doe 2022, 45).

If a direct quote is used, the page number is essential:

As noted, "the architectural styles are a testament to its rich past" (Doe 2022, 112).

Reference List Entry for a Book: Chicago Style

The reference list is an alphabetized compilation of all sources cited in the author-date system. It provides the complete publication details necessary for readers to locate the works. The format is similar to the bibliography in the notes-bibliography system, but with a slight alteration in punctuation and order of elements.

- **Format:** Last Name, First Name. Year of Publication. *Book Title*. City of Publication: Publisher.

The reference list entry for our example book would be:

Doe, Jane. 2022. *The History of Chicago*. Chicago: University of Chicago Press.

Variations in Chicago Style Book Citations

While the basic formats for single-author books are straightforward, Chicago style accommodates a wide range of publication types. Understanding how to cite books with multiple authors, editors, translators, or no author is essential for comprehensive referencing.

Book with One Author

This is the most common scenario and follows the basic formats detailed above. Ensure the author's name is spelled correctly and the title is italicized.

Book with Two or Three Authors

For books with two or three authors, all authors' names are included in the citation. In the notes-bibliography system, names are listed in the order they appear on the title page. In the author-date system, they are also listed in order, connected by "and."

- **Notes-Bibliography Full Note:** First Name Last Name and First Name Last Name, *Book Title* (City: Publisher, Year), Page.
- **Notes-Bibliography Bibliography:** Last Name, First Name, and First Name Last Name. *Book Title*. City: Publisher, Year.
- **Author-Date In-Text:** (First Name Last Name and First Name Last Name Year, Page)
- **Author-Date Reference List:** Last Name, First Name, and First Name Last

Name. Year. *Book Title*. City: Publisher.

Example:

1. John Smith and Mary Jones, *American Literature* (New York: Academic Press, 2021), 88. (Note)

Smith, John, and Mary Jones. 2021. *American Literature*. New York: Academic Press. (Reference List)

Book with More Than Three Authors

When a book has more than three authors, Chicago style typically lists only the first author's name in the citation, followed by "et al." (an abbreviation of the Latin "et alia," meaning "and others"). This simplifies the citation and avoids lengthy author lists.

- **Notes-Bibliography Full Note:** First Name Last Name et al., *Book Title* (City: Publisher, Year), Page.
- **Notes-Bibliography Bibliography:** Last Name, First Name, First Name Last Name, First Name Last Name, and First Name Last Name. *Book Title*. City: Publisher, Year. (Note: The bibliography lists all authors up to ten; for more than ten, list the first seven followed by et al.)
- **Author-Date In-Text:** (First Name Last Name et al. Year, Page)
- **Author-Date Reference List:** Last Name, First Name, First Name Last Name, First Name Last Name, and First Name Last Name. Year. *Book Title*. City: Publisher. (Note: The reference list for the author-date system also lists up to ten authors; for more than ten, list the first seven followed by et al.)

Example:

1. Robert Johnson et al., *World History* (London: Global Publishing, 2020), 150. (Note)

Johnson, Robert, Sarah Lee, David Chen, and Emily Rodriguez. 2020. *World History*. London: Global Publishing. (Reference List - example with four authors)

Edited Book

When citing a book that has been compiled or edited rather than authored by a single individual, the editor's role is highlighted. The format differentiates between citing the work as a whole and citing a specific chapter contributed by someone else within the edited volume (which will be covered later if applicable).

- **Notes-Bibliography Full Note:** First Name Last Name, ed., *Book Title* (City: Publisher, Year), Page.
- **Notes-Bibliography Bibliography:** Last Name, First Name, ed. *Book Title*. City: Publisher, Year.
- **Author-Date In-Text:** (Last Name Year, Page)
- **Author-Date Reference List:** Last Name, First Name, ed. Year. *Book Title*. City: Publisher.

Example:

1. Michael Brown, ed., *Essays on Modern Philosophy* (Oxford: Oxford University Press, 2019), 30. (Note)

Brown, Michael, ed. 2019. *Essays on Modern Philosophy*. Oxford: Oxford University Press. (Reference List)

Book with an Editor and Author

Some books have both an author for the content and an editor who compiled or annotated it. The citation should reflect both roles.

- **Notes-Bibliography Full Note:** Author First Name Last Name, *Book Title*, ed. Editor First Name Last Name (City: Publisher, Year), Page.
- **Notes-Bibliography Bibliography:** Author Last Name, First Name. *Book Title*. Edited by Editor First Name Last Name. City: Publisher, Year.
- **Author-Date In-Text:** (Author Last Name Year, Page)
- **Author-Date Reference List:** Author Last Name, First Name. Year. *Book Title*. Edited by Editor First Name Last Name. City: Publisher.

Example:

1. William Shakespeare, *Hamlet*, ed. Harold Bloom (New York: Modern Library, 2001), 5. (Note)

Shakespeare, William. 2001. *Hamlet*. Edited by Harold Bloom. New York: Modern Library. (Reference List)

Translated Book

When citing a book that has been translated from another language, it is important to include the translator's name. This acknowledges their contribution to making the work accessible in the target language.

- **Notes-Bibliography Full Note:** Original Author First Name Last Name, *Book Title*, trans. Translator First Name Last Name (City: Publisher, Year), Page.
- **Notes-Bibliography Bibliography:** Original Author Last Name, First Name. *Book Title*. Translated by Translator First Name Last Name. City: Publisher, Year.
- **Author-Date In-Text:** (Original Author Last Name Year, Page)
- **Author-Date Reference List:** Original Author Last Name, First Name. Year. *Book Title*. Translated by Translator First Name Last Name. City: Publisher.

Example:

1. Fyodor Dostoevsky, *Crime and Punishment*, trans. Constance Garnett (New York: Penguin Classics, 2001), 20. (Note)

Dostoevsky, Fyodor. 2001. *Crime and Punishment*. Translated by Constance Garnett. New York: Penguin Classics. (Reference List)

Book with No Author

In cases where a book lacks an explicit author, the citation begins with the title of the book. This is particularly common for reference works, anonymous classics, or publications where the organization or corporate body is considered the author.

- **Notes-Bibliography Full Note:** *Book Title* (City: Publisher, Year), Page.
- **Notes-Bibliography Bibliography:** *Book Title*. City: Publisher, Year.
- **Author-Date In-Text:** (*Shortened Book Title* Year, Page)
- **Author-Date Reference List:** *Book Title*. Year. City: Publisher.

Example:

1. *The Chicago Manual of Style* (Chicago: University of Chicago Press, 2017), 101. (Note)

The Chicago Manual of Style. 2017. Chicago: University of Chicago Press. (Reference List)

Electronic Books (E-books)

Citing e-books requires additional information, such as the format of the e-book and, if available, a stable URL or DOI (Digital Object Identifier). This

allows readers to access the digital version of the book.

- **Notes-Bibliography Full Note:** Author First Name Last Name, *Book Title* (City: Publisher, Year), Page, accessed Month Day, Year, Format (e.g., Kindle, PDF), URL or DOI.
- **Notes-Bibliography Bibliography:** Author Last Name, First Name. *Book Title*. City: Publisher, Year. Format (e.g., Kindle, PDF). Accessed Month Day, Year. URL or DOI.
- **Author-Date In-Text:** (Author Last Name Year, Page)
- **Author-Date Reference List:** Author Last Name, First Name. Year. *Book Title*. City: Publisher. Format (e.g., Kindle, PDF). Accessed Month Day, Year. URL or DOI.

Example:

1. Neil Postman, *Amusing Ourselves to Death* (New York: Penguin Books, 2011), 35, accessed October 26, 2023, Kindle,

Common Pitfalls in Chicago Style Book Citations

Q: What is the difference in the bibliography entry for an edited book versus a book with an author and editor in Chicago style?

A: For an edited book, the editor's name is preceded by "ed." in the bibliography: Last Name, First Name, ed. *Book Title*. City: Publisher, Year. For a book with both an author and an editor, the author is listed first, followed by "Edited by" and the editor's name: Author Last Name, First Name. *Book Title*. Edited by Editor First Name Last Name. City: Publisher, Year.

Q: Is it acceptable to use just the author's last name and year for subsequent notes in the notes-bibliography system if they are the only author I'm citing?

A: No, subsequent notes should always include a shortened version of the book title to avoid ambiguity, even if you are only citing one author. The format is: Last Name, *Shortened Book Title*, Page.

Q: For the author-date system, do I need to include the page number in every in-text citation?

A: Page numbers are required for direct quotations and paraphrased specific ideas. For general references to the entire work, page numbers may be omitted if the context is clear, but it's often best practice to include them for specificity.
