In the Author-Date system, the in-text citation would be (Smith 2021, 112) and the reference list entry:

Websites and Online Sources

Citing online materials requires careful attention to accessible information. For a webpage in the Notes-Bibliography system:

Author First Name Last Name (if available), "Title of Webpage," Name of Website, Publication Date (if available), accessed Month Day, Year, URL.

Example:

National Archives, "Magna Carta," The National Archives, last modified May 10, 2023, accessed October 26, 2023, <https://www.nationalarchives.gov.uk/education/resources/magna-carta/>.

In the Author-Date system, the in-text citation would be (National Archives n.d.) if no publication date is available, and the reference list entry:

National Archives. "Magna Carta." The National Archives. Last modified May 10, 2023. Accessed October 26, 2023.

In-Text Citations in Chicago Style for
