A reference list at the end of the document provides a full alphabetical listing of all sources cited. Chicago Style: Notes-Bibliography System for E-books

Core Components of an E-book Note Citation

When citing an e-book in the Notes-Bibliography system, several key pieces of information are essential. These include the author(s) or editor(s), the full title of the e-book (italicized), and publication details. For e-books, it's crucial to include information about the electronic format, such as the platform or the URL if it's freely accessible. The date of publication is also vital. Formatting a Note Citation for an E-book from a Database

When an e-book is accessed through an academic database (like JSTOR, Project MUSE, or EBSCOhost), the citation needs to reflect this origin. You'll include the author(s), italicized title, publisher, and publication year, followed by the name of the database (italicized), and then the URL or DOI if provided by the database. It's also important to note the date you accessed the material, as content within databases can sometimes be updated or removed.

Formatting a Note Citation for a Free E-book Online

For e-books that are freely available online, such as those found on Project Gutenberg or institutional repositories, the citation should clearly identify the author, italicized title, and then provide a stable URL. If the e-book mimics a print edition with clear pagination, you may include that information. Crucially, always include the date of access, as these freely available resources can change or disappear without notice. If there's no clear publisher or publication date, state "n.p." (no publisher) or "n.d." (no date) respectively, but strive to find this information.

Formatting an E-book in the Bibliography

The bibliography entry for an e-book closely resembles the note but with specific formatting adjustments. Author names are inverted (last name, first name). The title remains italicized. Publisher information, publication year, and the platform or URL are included. For purchased e-books without a DOI, you may simply indicate the format (e.g., Kindle Edition) or the vendor. For database e-books, you'll include the database name and URL. For free online e-books, the URL is paramount. Remember that the bibliography provides a complete alphabetical list of all cited sources.

Chicago Style: Author-Date System for E-books

Core Components of an E-book Author-Date Citation

In the Author-Date system, the core elements for citing an e-book are similar to the Notes-Bibliography system, but their placement and formatting within the text and reference list differ. You'll need the author(s) or editor(s) name(s), the publication year, the italicized title, publisher information, and details about the electronic format or access method. A stable URL or DOI is highly recommended for e-books to ensure verifiability, and the access date remains important for online resources.

Formatting an Author-Date Citation for a Purchased E-book

For purchased e-books, the in-text citation will consist of the author's last name and the publication year in parentheses. Formatting an Author-Date Citation for an E-book from a Database

Including the access date is still a best practice for dynamic online content.

Formatting an Author-Date Citation for a Free E-book Online

The reference list entry requires the author's last name, first initial/name, publication year, italicized title, and the direct, stable URL. If publishing information is absent, use "n.p." for no publisher and "n.d." for no date. Always include the access date.

Formatting an E-book in the Reference List

The reference list in the Author-Date system is an alphabetical compilation of all sources used in the paper. Each entry must contain the author's last name, first name (or initial), the publication year in parentheses, the full italicized title of the e-book, and then the publication details including publisher, DOI, or URL. The goal is to provide enough information for a reader to easily retrieve the source. Consistency in formatting across all entries is crucial for clarity and professionalism.

Key elements for a reference list entry include:

- Author's Last Name, First Name.
