Bibliography Example for Online Newspaper Article

The format for online newspaper articles is similar to print, with the addition of a URL.

- Author Last Name, First Name. "Title of Article." *Newspaper Name*, Month Day, Year. URL.

Subsequent notes would follow the standard shortened format:

2. Chen, "Tech Innovations,"

When citing online articles, it is crucial to use a stable and direct URL. Avoid citing general landing pages or complex permalinks that might change. If the article has a DOI (Digital Object Identifier), that is generally preferred over a URL.

Citing Newspaper Editorials and Op-Eds

Editorials and opinion pieces (Op-Eds) are distinct from news reporting and require specific notation in citations.

Bibliography Example for Editorial/Op-Ed
