Understanding Chicago Style: Notes and Bibliography vs. Author-Date

The Chicago Manual of Style (CMOS) offers two distinct citation systems: the Notes and Bibliography system and the Author-Date system. While both are governed by the same underlying principles, their application and presentation differ significantly. Edited Book: Notes and Bibliography System

For the Author-Date system, the in-text citation and the reference list entry are different. The in-text citation is brief, while the reference list entry provides full publication details.

Single-Author Book: Author-Date System

Smith, John R. 2021. *The History of Citation Practices*. Chicago: University of Chicago Press.

Chicago Style Citation Examples for Journal Articles

Journal articles are another common source type, and their citation requires specific formatting to

distinguish them from books. Key elements include the author(s), article title, journal title, volume and issue numbers, publication year, and page range.

Journal Article: Author-Date System

White, Emily. 2023. "The Impact of Digital Media on Modern Discourse." *Journal of Communication Studies* 15 (2): 50-65.

The Author-Date system includes the year prominently after the author's name in the reference list, and the in-text citation directly references this year.

Chicago Style Citation Examples for Websites and Online Resources

Citing online resources has become increasingly important, and CMOS provides guidelines for various web content. Essential elements often include the author (if known), the title of the specific page or article, the website name, and the URL. For online sources where the author is not identified, you start with the title. When a publication date is available, it should be included; otherwise, an access date is often used.

For the Author-Date system, online resources follow a similar structure to other sources, with the author and year being key for in-text citations.

bibliography entry would also include the edition number.
