If the article is part of a specific online database and the DOI points

directly to it, you would include the database name as well. The structure would then look like: Author Last Name, First Name. "Article Title." Journal Title Volume, no. Issue (Year): Page Numbers. Accessed Month Day, Year. DOI.

Article without a DOI (Using a Stable URL)

When an article within an online database lacks a DOI, you must provide a stable URL. It is crucial to find a URL that is as permanent as possible and leads directly to the article. Avoid generic search result pages or session-specific links. The format is similar to the DOI example, but replaces the DOI with the stable URL and includes an access date.

Online-Only Articles

If the article was created solely for an online publication within a database and does not have original page numbers or a volume/issue structure, the citation will be slightly different. It is important to ensure that the URL provided directs the user to the main page of the database, allowing them to explore its contents or understand its purpose.

Databases with Significant Editorial Content
