Understanding the Two Systems: Notes and Bibliography vs. Author-Date

Note the use of the author's full name in the first note and bibliography, but a shortened version in subsequent notes. The title is italicized in all instances. The bibliography entry omits page numbers for the entire work and reverses the author's name.

Book Citations in Author-Date System

The Author-Date system integrates source information directly into the text. Citations are parenthetical, usually appearing at the end of a sentence or clause. The bibliography at the end of the paper is called a "Reference List" and includes a more detailed entry for each source.

Citing Journal Articles

The bibliography entry omits the specific page number being cited and includes the full range of pages for the article. The journal title is italicized, and the article title is enclosed in quotation marks.

Journal Articles in Author-Date System

The Author-Date system requires parenthetical in-text citations and a reference list entry for journal articles.

- **In-Text Citation Example:** (Smith 2019, 78)
- **Reference List Entry Example:** Smith, John. 2019. "The Evolution of Modern Thought." *Journal of Intellectual History* 15 (2): 75-90.

The reference list entry format is similar to the Notes system but places the year after the author's name. Note that the volume and issue are presented slightly differently, and the page range is included.

Citing Websites and Online Resources

The digital age has introduced a vast array of online resources, and the Chicago style citation format offers guidelines for citing them. Key information for websites typically includes the author or organization responsible, the title of the specific page or article, the website name, a URL, and the date of access.

Websites in Notes and Bibliography System

For online resources in the Notes and Bibliography system, the note should include the author, title of the specific page or article, website name, and the URL. It is also crucial to include the date you accessed the material, as online content can change or disappear.

The bibliography entry omits the specific access date unless there is no publication date available. The title of the page is usually placed in quotation marks, and the website name is sometimes italicized or treated as part of the publication information.

Websites in Author-Date System

In the Author-Date system, online resource citations require a reference list entry. The in-text citation will depend on whether an author or an organization is listed as the source. If no author is available, the title of the page or website may be used in place of the author's name.

- **Reference List Entry Example (with author):** Doe, Jane. 2022. "Digital Archiving Practices." History Hub. Accessed May 15, 2023. <https://www.historyhub.com/digital-archiving>.

The in-text citation would follow standard Author-Date format, e.g., (Doe 2022) or ("Digital Archiving Practices" 2022).

Citing Other Source Types

Beyond books and journal articles, academic research often involves a variety of other source materials. The Chicago style citation format provides specific guidance for citing a wide range of these, ensuring comprehensive and accurate referencing across different media.

Audiovisual Materials

When citing films, documentaries, or other audiovisual works, you'll typically include the director, title (*italicized*), production company, and year of release. For specific points, you might include time stamps.

- **Author-Date Reference List Example:** Nolan, Christopher, director. 2010. *Inception*. Burbank, CA: Warner Bros. Pictures.

Interviews

Citing interviews, whether conducted by the researcher or published, requires detailing the interviewee, the interviewer (if applicable), the date, and the format or location of the interview.

- **Note Example:** 7. Interview with Alice Brown, by Robert Green, April 10, 2021, phone interview.
- **Bibliography Entry Example:** Brown, Alice. Interview by Robert Green. April 10, 2021. Phone interview.
- **Author-Date Reference List Example:** Brown, Alice. 2021. Interview by Robert Green. April 10, 2021. Phone interview.

Reports and Dissertations

Formal reports and dissertations/theses are also common sources. They require information about the author, title, type of document, and where it was published or presented.

- **Note Example:** 8. United Nations, *World Economic Outlook* (New York: United Nations Publications, 2018), 25.
- **Bibliography Entry Example:** United Nations. *World Economic Outlook*. New York: United Nations Publications, 2018.
- **Author-Date Reference List Example:** United Nations. 2018. *World Economic Outlook*. New York: United Nations Publications.
