## Citing Websites and Online Sources

Citing websites and other online sources requires a slightly different approach, as the stability and availability of online content can vary. Key information includes the author or organization responsible for the content, the title of the specific page or document, the name of the website, the publication or last updated date (if available), and the full URL. An access date is also crucial for online sources.

For online articles or web pages with an identified author: Author Last Name, First Name. "Title of Web Page." Name of Website. Publication Date. Accessed Month Day, Year. URL. If no author is listed, the entry begins with the title. For instance: {" "}
