Understanding the Chicago Manual of Style

Two Systems of Citation: Notes-Bibliography and

Author-Date

The Chicago Manual of Style offers two primary citation systems: the notes-bibliography system and the author-date system. Each system serves a slightly different purpose and is preferred in different academic fields. Understanding the distinctions between them is the first step in correctly citing your scholarly articles.

The Notes-Bibliography System

The notes-bibliography system is characterized by the use of numbered footnotes or endnotes within the text, with a corresponding bibliography at the end of the paper. This system is prevalent in fields like history, literature, and the arts. The numbered notes provide detailed citation information, allowing for multiple citations of the same source within the text without excessive repetition. The bibliography then offers a consolidated list of all sources consulted and cited.

In this system, each footnote or endnote contains full publication details for the first citation of a source. Subsequent citations of the same source are typically shortened, often including the author's last name, a shortened title, and a page number. This approach allows for brief, unobtrusive interruptions in the main text while still providing complete source information readily available at the end of the page or document.

The Author-Date System

The author-date system, on the other hand, relies on brief in-text citations that include the author's last name and the year of publication. These in-text citations correspond to a full reference list (often titled "References" or "Works Cited") at the end of the document, which includes complete publication details for all sources cited. This system is more common in the social sciences and natural sciences, as it emphasizes the chronology of research and is often preferred for its conciseness within the running text.

The in-text citations are usually placed in parentheses at the end of a sentence or clause, immediately after the relevant information has been presented. For instance, a typical in-text citation might appear as (Smith 2020). This direct association between the textual claim and its source year helps readers quickly identify the origin of the information and its temporal context.

Core Elements of a Chicago Style Citation for Scholarly Articles

Regardless of the system employed, Chicago style citations for scholarly articles share common essential components. These elements ensure that readers have all the necessary information to locate and verify the source. Understanding these core elements is crucial for constructing accurate

and complete citations.

The fundamental pieces of information required for citing a scholarly article typically include the author(s)' name(s), the title of the article, the title of the journal or publication, the volume and issue numbers, the year of publication, and the page numbers where the article can be found. For online sources, additional information such as a URL or DOI (Digital Object Identifier) is also necessary.

Citing Journal Articles in the Notes-Bibliography System

Citing journal articles within the notes-bibliography system requires careful attention to detail to provide both complete and abbreviated references. The first time an article is cited, the note should include all essential bibliographic information.

First Note Citation for a Journal Article

The initial note for a journal article should include the author's full name (first and last), the article's title in quotation marks, the journal's title in italics, the volume number, the issue number, the publication year in parentheses, and the specific page number(s) being referenced. For instance: 1. Jane Doe, "The Evolution of Citation Practices," *Journal of Academic Writing* 45, no. 2 (2021): 112.

It is important to use precise punctuation. Commas separate different elements, and a period concludes the note. The inclusion of the issue number is important if the journal paginates each issue separately. If the journal paginates continuously throughout a volume, the issue number might be omitted, but it is generally best practice to include it if available.

Subsequent Note Citation for a Journal Article

For any subsequent citations of the same article within the same paper, a shortened form of the note is used. This typically includes the author's last name, a shortened version of the article title (if it is long), and the page number(s) being cited. For example: 2. Doe, "Evolution of Citation Practices," 115.

If the author has multiple works cited in the paper, it is often necessary to include a shortened title to distinguish between them. The goal of the shortened note is to be brief yet informative enough for the reader to easily identify the source in the bibliography.

Bibliography Entry for a Journal Article

The bibliography entry for a journal article in the notes-bibliography system is similar to the first note but follows a slightly different format, typically with the author's last name first. The author's full name (last name, first name), the article's title in quotation marks, the journal's title in italics, the volume number, the issue number, the publication year in parentheses, and the inclusive page numbers of the article are all included. For example: Doe, Jane. "The Evolution of Citation Practices." *Journal of Academic Writing* 45, no. 2 (2021): 110–130.

The bibliography is an alphabetical list of all sources cited in the paper. Page numbers in the bibliography entry refer to the entire range of pages for the article, not just the specific pages cited in the notes.

Citing Journal Articles in the Author-Date System

The author-date system offers a more streamlined approach to in-text citations, making it ideal for disciplines where quick referencing is prioritized.

In-Text Citations for Journal Articles

In the author-date system, in-text citations consist of the author's last name and the year of publication, often enclosed in parentheses. For example: (Smith 2020). If a specific page number is being referenced, it is included after the year, separated by a comma: (Smith 2020, 45).

When the author's name is mentioned in the text, only the year needs to be placed in parentheses: Smith (2020) argues that... . If citing multiple works by the same author in the same year, letters (a, b, c) are appended to the year to differentiate them, e.g., (Smith 2020a). The full details for these are then provided in the reference list.

Reference List Entry for a Journal Article

The reference list entry for a journal article in the author-date system includes the author's full name (last name, first name), the publication year in parentheses, the article title, the journal title in italics, the volume number, the issue number, and the inclusive page numbers. For example: Smith, John. 2020. "The Impact of Citation Styles on Academic Research." *Journal of Scholarly Publishing* 50, no. 1: 20-35.

The key difference from the notes-bibliography system's bibliography is the placement of the publication year immediately after the author's name and the use of a period after the year. The entire list is alphabetized by the author's last name.

Citing Online Scholarly Articles and Databases

The digital age has introduced new complexities to citation practices. Citing online scholarly articles requires attention to identifiers like DOIs and URLs, as well as access dates when necessary.

Online Journal Articles with DOIs

When citing online journal articles that have a DOI, this is the preferred identifier. The DOI provides a persistent link to the article, ensuring it remains accessible even if the URL changes. The format for a DOI citation in notes-bibliography system is generally: Author, "Article Title," *Journal Title* Volume, no. Issue (Year): Page numbers, DOI.

In the author-date system, it would be: Author. Year. "Article Title." *Journal Title* Volume, no. Issue: Page numbers. DOI.

Online Journal Articles without DOIs

If an online journal article lacks a DOI, a URL is provided instead. It is also recommended to include an access date if the content is likely to change over time. The format for a notes-bibliography system note: Author, "Article Title," *Journal Title* Volume, no. Issue (Year): Page numbers, accessed Month Day, Year, URL.

For the author-date system reference list: Author. Year. "Article Title." *Journal Title* Volume, no. Issue: Page numbers. Accessed Month Day, Year. URL.

Articles from Academic Databases

Citing articles retrieved from academic databases often involves a similar structure to other online articles. However, the database name and the accession number (if provided and deemed necessary by the specific guidelines being followed) might be included. The core information about the author, article title, journal title, volume, issue, year, and pages remains paramount.

It's crucial to check the specific database's recommendations or the journal's author guidelines, as practices can sometimes vary. The goal is always to provide enough information for the reader to find the exact source.

Citing Other Scholarly Works (Books, Book Chapters)

While this guide focuses on scholarly articles, it's important to note that Chicago style also governs the citation of other scholarly materials like books and book chapters, which often appear in bibliographies alongside articles.

Books

For a book in the notes-bibliography system, a full note includes author(s), title (italicized), place of publication, publisher, and year of publication. For example: 3. Michael Pollan, *The Omnivore's Dilemma: A Natural History of Four Meals* (New York: Penguin Press, 2006).

In the author-date system reference list: Pollan, Michael. 2006. *The Omnivore's Dilemma: A Natural History of Four Meals*. New York: Penguin Press.

Book Chapters

Citing a chapter in an edited book requires referencing both the chapter author and the editor(s) of the book. In the notes-bibliography system, a note might look like: 4. David Crystal, "The Cambridge Encyclopedia of the English Language," in *The Cambridge Encyclopedia of the English Language*, ed. David Crystal, 2nd ed. (Cambridge: Cambridge University Press, 2003), 345-347.

The corresponding reference list entry in the author-date system would be: Crystal, David. 2003. "The Cambridge Encyclopedia of the English Language." In *The Cambridge Encyclopedia of the English Language*, edited by David Crystal, 2nd ed., 345-347. Cambridge: Cambridge University Press.

Formatting and Style Considerations

Beyond the core bibliographic information, several formatting and style conventions within Chicago style are essential for scholarly articles. These details contribute to the overall professionalism and readability of your work.

Punctuation, capitalization, and the use of italics and quotation marks must be consistent throughout. For example, article titles are typically enclosed in quotation marks, while journal titles are italicized. Author names are presented in a specific order, and elements within citations are separated by commas and periods as prescribed by the manual.

- **Author Names:** In notes, first name then last name. In bibliographies/reference lists, last name first.
- **Titles:** Article titles in quotation marks. Journal titles in italics.
- **Publication Information:** City of publication, publisher, year.
- **Page Numbers:** Use "p." for a single page and "pp." for a range in notes. In bibliography/reference list, typically inclusive page numbers are given.

Common Pitfalls and Best Practices
