KEY COMPONENTS OF A STRONG CHICAGO STYLE CONCLUSION

CONSIDER THE PRACTICAL APPLICATIONS, THEORETICAL ADVANCEMENTS, OR NEW PERSPECTIVES YOUR RESEARCH OFFERS. THIS ASPECT OF THE CONCLUSION ELEVATES THE PAPER FROM A DESCRIPTIVE ACCOUNT TO AN INSIGHTFUL ANALYSIS WITH LASTING VALUE.

OFFERING SUGGESTIONS FOR FUTURE RESEARCH

CONCLUDING A CHICAGO STYLE PAPER OFTEN INVOLVES POINTING TOWARDS FUTURE AVENUES OF INQUIRY. MERELY SUMMARIZING WITHOUT SYNTHESIS

A COMMON MISTAKE IS TO SIMPLY RESTATE THE MAIN POINTS OF EACH SECTION WITHOUT ANY ANALYTICAL CONNECTION. THIS APPROACH IS OFTEN REFERRED TO AS A "LAUNDRY LIST" SUMMARY. TRUE SYNTHESIS INVOLVES SHOWING HOW THESE POINTS RELATE TO EACH OTHER AND, MORE IMPORTANTLY, HOW THEY COLLECTIVELY PROVE THE THESIS. THE CONCLUSION NEEDS TO DEMONSTRATE A HIGHER LEVEL OF UNDERSTANDING THAN A SIMPLE RECAP.

BEING TOO REPETITIVE

WHILE RESTATING THE THESIS AND KEY ARGUMENTS IS NECESSARY, EXCESSIVE REPETITION CAN MAKE THE CONCLUSION TEDIOUS. THE GOAL IS TO REPHRASE AND RECONTEXTUALIZE, NOT TO COPY AND PASTE SENTENCES OR IDEAS DIRECTLY FROM THE BODY OF THE PAPER. VARYING SENTENCE STRUCTURE AND VOCABULARY ARE KEY TO AVOIDING MONOTONY AND KEEPING THE READER ENGAGED UNTIL THE VERY END.

FAILING TO CONNECT BACK TO THE INTRODUCTION

A STRONG CONCLUSION SHOULD CREATE A SENSE OF COMPLETENESS BY SUBTLY ECHOING THE INTRODUCTION. IF THE INTRODUCTION POSED A QUESTION OR PRESENTED A PROBLEM, THE CONCLUSION SHOULD DEMONSTRATE HOW THAT QUESTION HAS BEEN ANSWERED OR THAT PROBLEM HAS BEEN ADDRESSED. THIS CYCLICAL APPROACH PROVIDES A SATISFYING SENSE OF CLOSURE AND REINFORCES THE PAPER'S COHERENCE AND PURPOSE FROM BEGINNING TO END.

CRAFTING YOUR CHICAGO STYLE CONCLUSION: A STEP-BY-STEP APPROACH

7. REVIEW YOUR DRAFT TO ENSURE IT FLOWS LOGICALLY, AVOIDS NEW INFORMATION, AND DOESN'T SIMPLY REPEAT WHAT'S ALREADY BEEN SAID.
8. CHECK FOR CLARITY, CONCISENESS, AND A STRONG, AUTHORITATIVE TONE, CONSISTENT WITH THE CHICAGO MANUAL OF STYLE.

ILLUSTRATIVE CHICAGO STYLE CONCLUSION SAMPLE PAPER ELEMENTS

THE FINAL POLISH: EDITING AND REFINING YOUR CONCLUSION

THE FINAL STAGE OF CRAFTING YOUR CHICAGO STYLE CONCLUSION INVOLVES METICULOUS EDITING AND REFINEMENT.
