OFFER NEW PERSPECTIVES OR INSIGHTS

A TRULY EFFECTIVE CONCLUSION CAN INTRODUCE A NOVEL PERSPECTIVE THAT THE BODY OF THE PAPER HAS IMPLICITLY LED TO BUT NOT EXPLICITLY STATED. THIS MIGHT BE A FRESH INTERPRETATION OF THE EVIDENCE, A REALIZATION THAT EMERGED FROM THE ANALYSIS, OR A NUANCED UNDERSTANDING THAT THE READER CAN NOW GRASP MORE FULLY. IT'S ABOUT PROVIDING THAT "AHA!" MOMENT.

SUGGEST FUTURE DIRECTIONS FOR RESEARCH

FOR ACADEMIC PAPERS, PROPOSING AVENUES FOR FUTURE INQUIRY IS AN EXCELLENT WAY TO MOVE BEYOND SUMMARY. THIS DEMONSTRATES AN UNDERSTANDING OF THE LIMITATIONS OF CURRENT KNOWLEDGE AND THE POTENTIAL FOR FURTHER EXPLORATION. ANY NEW INFORMATION SHOULD HAVE BEEN INTEGRATED AND DISCUSSED WITHIN THE BODY OF THE PAPER.

OVER-SUMMARIZING OR BEING REPETITIVE

AS EMPHASIZED THROUGHOUT, A CONCLUSION IS NOT A SUMMARY. SIMPLY RESTATING POINTS MADE IN THE INTRODUCTION OR BODY PARAGRAPHS VERBATIM, OR IN A NEARLY IDENTICAL FASHION, DIMINISHES THE IMPACT. THE GOAL IS SYNTHESIS AND EXTENSION, NOT REPETITION. READERS APPRECIATE INSIGHTS THAT BUILD UPON THEIR UNDERSTANDING, NOT JUST ECHO IT.

ENDING ABRUPTLY OR WEAKLY

A CONCLUSION SHOULD PROVIDE A SENSE OF DEFINITIVE CLOSURE. ENDING TOO ABRUPTLY, WITHOUT A CLEAR SENSE OF FINALITY OR A THOUGHTFUL FINAL STATEMENT, CAN LEAVE THE READER FEELING UNSATISFIED. CONVERSELY, A WEAK OR UNINSPIRED CLOSING CAN UNDERMINE THE STRENGTH OF THE ENTIRE PIECE.

APOLOGIZING FOR LIMITATIONS OR FINDINGS

WHILE ACKNOWLEDGING LIMITATIONS CAN BE VALUABLE, FRAMING THEM AS APOLOGIES OR EXCUSES FOR THE RESEARCH CAN WEAKEN THE OVERALL ARGUMENT. THE CONCLUSION SHOULD PRESENT FINDINGS AND INSIGHTS CONFIDENTLY, WITH AN UNDERSTANDING OF THE RESEARCH CONTEXT AND POTENTIAL FOR FURTHER DEVELOPMENT, RATHER THAN AS JUSTIFICATIONS FOR PERCEIVED SHORTCOMINGS.

THE ROLE OF THE CONCLUSION IN THE CHICAGO MANUAL OF STYLE

THE CHICAGO MANUAL OF STYLE (CMOS) PROVIDES GUIDELINES THAT, WHILE NOT DICTATING EVERY WORD OF A CONCLUSION, STRONGLY INFLUENCE ITS STRUCTURE AND PURPOSE. CMOS EMPHASIZES CLARITY, COHERENCE, AND THE OVERALL LOGICAL FLOW OF A WRITTEN WORK. IN THIS CONTEXT, THE CONCLUSION IS UNDERSTOOD AS THE INTEGRAL COMPONENT THAT BRINGS ALL THESE ELEMENTS TO FRUITION.

CMOS ADVOCATES FOR A CONCLUSION THAT EFFECTIVELY BRINGS AN ARGUMENT TO ITS LOGICAL END, REINFORCING THE THESIS WITHOUT REDUNDANCY. THE EMPHASIS IS ALWAYS ON THE READER'S COMPREHENSIVE UNDERSTANDING AND THE LASTING IMPACT OF THE WRITTEN PIECE.

ENSURING COHESION WITH THE ENTIRE DOCUMENT
