Instead of numbered notes, short parenthetical citations are used directly within the text. These citations typically include the author's last name and the year of publication, followed by a page number if a specific passage is being referenced (e.g., Smith 2020, 45). This immediate attribution of information to its source helps readers quickly identify the origin of claims being made.

Complementing the in-text citations, the Author-Date system requires a reference list at the end of the paper. This list includes all sources cited in the text, again arranged alphabetically by the author's last name.

Each entry in the reference list provides the full bibliographic details necessary for readers to locate the source, including author, year, title, and publication information. In-Text Citations for Author-Date

The Author-Date system requires parenthetical citations embedded directly within the text. These citations are typically placed at the end of the sentence or clause that contains the borrowed information, before the final punctuation. The standard format includes the author's last name and the year of publication, separated by a comma. If you are citing a specific passage, a page number is also included after the year, preceded by a comma.

For example: The influence of technology on societal development is undeniable (Jones 2019, 112). If the author's name is mentioned in the text, it can be omitted from the parenthetical citation: As Jones argues, the influence of technology on societal development is undeniable (2019, 112). If a work has multiple authors, the citation format adapts accordingly (e.g., Smith and Chen 2021, 55 for two authors, or Lee et al.

2018 for three or more authors).

Building a Comprehensive Bibliography or Reference List

The concluding section of your Chicago style essay paper is dedicated to providing a complete listing of all sources consulted and cited. This section is crucial for allowing your readers to trace your research and explore the materials you relied upon. The exact title and format of this list depend on the citation system you are using.

The Bibliography in Notes and Bibliography System
