Notes and Bibliography System: Citing Dissertations

The Notes and Bibliography system, prevalent in the humanities, requires detailed citations in both footnotes or endnotes and a comprehensive bibliography at the end of your work. When citing a doctoral dissertation, these formats ensure readers can precisely locate the source material.

Footnote/Endnote Format for Dissertations

This includes the country if the university is not widely known internationally or if there is potential for confusion with similarly named institutions.

For a dissertation from an international university in the Notes and Bibliography system (footnote/endnote):
