Understanding Chicago Style Citation Systems

The Chicago Manual of Style offers two distinct citation systems, each serving different academic and publication needs. The choice between them significantly impacts how your reference list will appear. It is imperative to know which system your institution or publisher requires before you begin compiling your citations.

The Notes-Bibliography System

This system is prevalent in the humanities, including literature, history, and the arts. It utilizes footnotes or endnotes to cite sources within the text. Consequently, the reference list, typically titled "Bibliography," includes all sources cited in the notes, often in a slightly more detailed format than the initial note. The bibliography is usually arranged alphabetically by author's last name.

The Author-Date System

The author-date system, common in the social sciences and natural sciences, uses parenthetical in-text citations that include the author's last name and the year of publication (e.g., Smith 2020). The reference list, often titled "Reference List," provides full bibliographic details for each source cited in the text, also organized alphabetically. This system allows readers to quickly identify the source and publication date directly within the narrative.

Title of the Work

Publication Information

This includes essential details about where and when the work was published. For books, this typically involves the place of publication, the publisher's name, and the year of publication. For journal articles, it includes the journal title (italicized), volume number, issue number, and the page range of the article. Online resources will include the website name and the URL.

Page Numbers (when applicable)

For sources where you are referencing a specific part of the work, such as a direct quote or a paraphrase from a book or article, you will include the relevant page number(s) in your in-text citation. These are not always included in the bibliography entry itself unless referring to a specific edition or if it's the only way to identify the material.

Chicago Style Examples for Books

A Single-Author Book

This is a foundational example for citing a book. Note the order of the author's name and the use of

italics for the book title.

An Edited Book

When citing an entire edited book, the editor(s) are listed, often with an abbreviation indicating their role.

A Chapter or Part of an Edited Book

Citing a specific contribution within an edited volume requires citing both the author of the chapter and the details of the larger work.

When a DOI is not available, the URL of the article, along with the access date, is typically provided.

A Journal Article from a Print Subscription Database

When the article is accessed through a subscription database and lacks a DOI, the database name and accession number might be included.

The internet has become a vast repository of information. Citing online sources requires careful attention to detail, including the website name, author (if available), title, publication date, and URL.

A Webpage with an Author

When a specific author is credited for the content of a webpage, their name should be included.

A Blog Post

Blog posts are cited similarly to other webpages, with emphasis on the author, post title, blog name, and date.

Formatting Your Reference List in Chicago Style

Alphabetical Order

All entries in your reference list, whether for the notes-bibliography or author-date system, must be arranged in alphabetical order based on the first word of each entry, typically the author's last name. If an entry has no author, it is alphabetized by the title.
