Understanding Chicago Style's Dual Citation Systems

The Chicago Manual of Style (CMOS) offers two distinct citation systems: the Notes and Bibliography system and the Author-Date system. The Notes and Bibliography system relies on superscript numbers within the text that correspond to detailed footnotes or endnotes, with a comprehensive bibliography at the end of the work. The Author-Date system, conversely, uses parenthetical citations in the text (Author Year, page number) and a reference list at the end. This method is prevalent in fields like political science, psychology, and economics, where it facilitates quick referencing and a streamlined reading experience. The decision between the Notes and Bibliography system and the Author-Date

system is not arbitrary; it reflects differing disciplinary conventions and the emphasis placed on source interaction. In fields where tracing the lineage of ideas and engaging in detailed scholarly dialogue is central, the Notes and Bibliography system allows for rich commentary and explanation within the notes themselves, which can be lost in the more concise Author-Date format. Conversely, in scientific and quantitative social sciences, the Author-Date system prioritizes efficiency and direct attribution, allowing readers to easily locate the cited source without interrupting the flow of the main text. Familiarizing yourself with the expectations of your specific field and the requirements of your intended publication is therefore crucial when making this foundational choice.

Navigating In-Text Citations and Notes

The Notes and Bibliography System: Footnotes and Endnotes

When employing the Notes and Bibliography system, citations appear as superscript numbers within the text, keyed to either footnotes at the bottom of the page or endnotes at the conclusion of the document. Each note provides a full citation for the first mention of a source, and subsequent mentions are typically shortened. For example, a first reference to a book might look like this in a footnote: 1. Michel Foucault, *Discipline and Punish: The Birth of the Prison* (New York: Vintage Books, 1995), 25.

Subsequent references to the same source are then condensed. If you were to cite Foucault again shortly after the first mention, the note might appear as: 2. Foucault, *Discipline and Punish*, 50. If the same source is cited consecutively, the note can be simply "Ibid." (Latin for "in the same place"), followed by the page number if different: 3. Ibid., 72. This system allows for extensive explanatory notes or commentary alongside direct citations, enriching the scholarly apparatus of the work.

The Author-Date System: Parenthetical Citations

The Author-Date system replaces notes with brief parenthetical citations directly within the text. These typically include the author's last name, the year of publication, and the page number(s). For instance, a citation might appear as (Smith 2020, 112). If the author's name is already mentioned in the sentence, only the year and page number are needed: As argued by Smith (2020, 112), the implications are significant. This system is designed for conciseness and allows readers to quickly identify the source of information and locate it in the corresponding reference list.

When citing multiple authors or works within the same parenthetical

reference, Chicago style provides specific formats. For two authors, list both last names separated by "and": (Johnson and Lee 2019, 45). For three or more authors, use the first author's last name followed by "et al.": (Garcia et al. 2021, 88). When citing multiple works by the same author in the same year, they are distinguished by lowercase letters following the year (e.g., Jones 2018a, 2018b). For multiple sources within a single parenthetical citation, list them alphabetically by author, separated by semicolons: (Brown 2017; Davis 2018; Evans 2019).

Crafting Effective Bibliographies and Reference Lists

The Bibliography in the Notes and Bibliography System

A bibliography in the Notes and Bibliography system serves as a comprehensive alphabetical list of all the sources cited in the text. It is placed at the end of the document. Each entry should include all necessary publication information, allowing readers to locate the original source. The formatting for bibliographic entries closely mirrors that of the first note for each source but typically omits page numbers unless referring to a specific section of a larger work. For a book, it would appear as: Foucault, Michel. *Discipline and Punish: The Birth of the Prison*. New York: Vintage Books, 1995.

Journal articles are also listed with author, article title, journal title, volume, issue, and publication year, followed by the page range of the article: Putnam, Robert D. "Bowling Alone: America's Declining Social Capital." *Journal of Democracy* 6, no. 1 (1995): 65–78. The key is consistency and providing enough information for retrieval. All entries are alphabetized by the author's last name. If an author has multiple works cited, they are listed chronologically by publication year.

The Reference List in the Author-Date System

The Author-Date system culminates in a reference list, also alphabetized by author's last name. Unlike the bibliography, the reference list contains only the sources that were actually cited in the text, and the format of each entry is slightly different to align with the parenthetical citations. For a book: Smith, John. 2020. *The Social Contract in the 21st Century*. New York: Oxford University Press. Note the inclusion of the publication year immediately after the author's name.

Journal articles in the reference list include the author(s), year, article

title, journal title, volume, issue, and page range: Garcia, Maria, David Chen, and Sarah Miller. 2021. "Urbanization and Community Cohesion." *Sociological Review* 45, no. 3: 210–235. The structure of the reference list is critical for the efficacy of the Author-Date system, enabling readers to swiftly find the cited works. Ensuring accuracy and completeness in every entry is paramount for academic integrity.

Formatting Key Social Science Sources

Citing Books

Books are fundamental resources in the social sciences. Whether you are citing a monograph, an edited volume, or a chapter within an edited volume, Chicago style has specific guidelines. For a single-authored book in the Notes and Bibliography system:

Citing Websites and Online Sources

The digital age has made online sources increasingly common in social science research. When citing a webpage or online article, it is crucial to include the most stable URL and the date you accessed the material. For the Notes and Bibliography system:

Manuscript Formatting
