Citing Paraphrased Websites and Online Content

Citing online sources can be more varied, but a Chicago style footnote for paraphrased website content should include the author (if available), the

page title, the website name, and the URL. Including a retrieval date is also good practice for online sources, as content can change. Page numbers are less common for websites unless the content is paginated.

Key Differences: Direct Quote Footnote vs. Paraphrased Footnote

The primary difference between a footnote for a direct quote and one for a paraphrase lies in how the source material is presented in your text. For a direct quote, you use quotation marks around the exact words of the author. The footnote then points to the precise location of that quote. For a paraphrase, you are restating the author's idea in your own words. While the footnote still points to the location of the idea (the page number), the text you present is your own composition.
