Understanding the Basics of Chicago Style Footnotes

The Chicago Manual of Style (CMOS) offers two primary citation systems: notes and bibliography, and author-date. This article focuses exclusively on the notes and bibliography system, which is prevalent in the humanities and arts. In this system, brief notes are placed at the bottom of the page (footnotes) or at the end of the document (endnotes) to refer the reader to the source of information. These notes are typically paired with a full bibliography at the end of the work, providing a complete list of all sources consulted.

The core principle of the notes and bibliography system is to provide readers with sufficient information to locate the original source without being overly intrusive within the main text. For recurring sources, especially those by the same author, Chicago style provides specific guidelines to streamline these citations and prevent redundancy. The Initial Footnote Citation for a Same Author

When you cite a work by a particular author for the first time in your footnotes, you must provide a full citation. This includes all the necessary bibliographic information so that the reader can easily identify the source. This full note acts as the primary reference point for that specific work within your document. For a book, this typically includes the author's full name, the title of the book in italics, publication information (city, publisher, year), and the specific page number(s) being referenced.

For example, if you are citing a book by Jane Doe titled "The History of Ancient Rome," published in 2020 by Chicago University Press in Chicago, and you are referencing page 55, the initial footnote would look like this:

1. Jane Doe, *The History of Ancient Rome* (Chicago: Chicago University Press, 2020), 55.

Subsequent Footnote Citations for the Same Author

Once a source has been fully cited in a footnote, subsequent references to the same work by the same author can be shortened. This is where the "same author" rule becomes particularly important. Instead of repeating the full bibliographic details every time, Chicago style allows for a condensed note. The specific format depends on whether you are citing the same work multiple times in a row or if other sources intervene.

If you are citing the same work immediately after the previous footnote, you would use "Ibid." (an abbreviation of the Latin word "ibidem," meaning "in the same place"). However, if you have cited another source in between, or if you are referencing the same work by the same author but it is not the immediately preceding footnote, you cannot use "Ibid." In such cases, you must use a shortened note. This shortened note typically includes the author's last name, a shortened version of the title (if it's long or if you are citing multiple works by the same author), and the page number.

Shortened Notes with the Same Author

When you need to cite the same author's work again but not immediately, the shortened note is essential. The format usually involves the author's last name, a shortened title of the work (often italicized if it's a book), and the page number. This system is particularly helpful when you are referencing several works by the same author, as it allows you to distinguish between them more clearly.

Continuing with our example of Jane Doe, if you had cited another source after the first mention of "The History of Ancient Rome," and now you need to refer to page 75 of that same book, the shortened footnote would appear as:

1. Doe, *History of Ancient Rome*, 75.

It is crucial to ensure consistency in the shortened title you use throughout your document. If you are citing multiple works by Jane Doe, you might need to further differentiate them. For instance, if she also wrote "Roman Society in the Republic" (2022), your citations might look like:

- Doe, *History of Ancient Rome*, 75.
- Doe, *Roman Society*, 120.

Variations and Special Cases

While the general rules for citing the same author are clear, there are a few variations and special cases to consider. For instance, if you are citing multiple works by the same author, the shortened note format is paramount for clarity. If the author has only one work cited in your bibliography, you can sometimes omit the title in the shortened note after the first full citation, although using the shortened title is generally preferred for absolute clarity.

The Importance of the Bibliography

The bibliography, appearing at the end of your paper, is a comprehensive list of all the sources you have cited in your footnotes or endnotes. It serves as a vital tool for your readers, allowing them to find the full details of every source you've referenced. When multiple works by the same author are included, the bibliography must be meticulously organized to facilitate easy identification and retrieval of each individual source.

The bibliography entries for the same author are typically alphabetized by the author's last name. If you have multiple entries for the same author, they are then sub-alphabetized by the title of the work. This systematic arrangement is a hallmark of the Chicago style and ensures that your references are not only accurate but also user-friendly for your audience.

Formatting the Bibliography for the Same Author

When listing multiple works by the same author in your bibliography, Chicago style employs a specific convention to avoid repetition. After the first entry for an author, subsequent entries by that same author will replace the author's full name with a long dash (an em dash, which is longer than a hyphen and shorter than an en dash) followed by a comma. This long dash signifies that the author is the same as the one in the preceding entry.

For example, if Jane Doe has two books in your bibliography, "The History of Ancient Rome" and "Roman Society in the Republic," the bibliography entries would appear as follows:

- Doe, Jane. *The History of Ancient Rome*. Chicago: Chicago University Press, 2020.
- —. *Roman Society in the Republic*. Chicago: Chicago University Press, 2022.

This formatting convention is a key feature of Chicago style bibliographies and is crucial for presenting a clean and organized list of references, especially when dealing with numerous works by a single author.

When to Use Shortened Notes

The decision to use shortened notes is primarily dictated by the context of your citation. As previously mentioned, "Ibid." is used for consecutive citations of the exact same source. However, once the source is no longer consecutive, or if you are citing a different page from the same source after an intervening citation, you must switch to a shortened note. This rule applies whether the intervening source is by the same author or a different one.

The primary purpose of shortened notes is to provide a concise identifier for a previously cited work without overwhelming the reader with repetitive full bibliographic information. This balance between brevity and clarity is what makes the Chicago style efficient for scholarly writing. The rule of thumb is to use the shortened note whenever "Ibid." is no longer applicable for a repeated source.

Bibliography entries would appear as:

- Vance, Eleanor. *Avian Migrations Across Continents*. New York: Ornithology Press, 2018.
- —. *The Science of Birdsong*. New York: Ornithology Press, 2021.
- Chen, David. *Ecology of Urban Birds*. London: Nature Publishing, 2019.

This example demonstrates the progression from full citation to "Ibid." and then to shortened notes, as well as the distinct formatting of the bibliography for multiple works by the same author. The key is consistent application of these rules throughout your document.
