If quoting directly, the page number from which the quotation is taken is essential. For paraphrased ideas or summarized information, a page number is still often recommended by CMOS, especially for works where specific arguments are spread across multiple pages.

In-Text Citations for the Author-Date System

For dissertations employing the author-date system, in-text citations appear directly within the text, enclosed in parentheses. The format is typically (Author's Last Name Year, Page Number). For example:

Scholars have long debated the influence of Romanticism on contemporary poetry (Bloom 1973, 105).

When the author's name is mentioned in the sentence, only the year and page number are needed in parentheses:

Bloom argued that Romanticism significantly influenced later poetic movements (1973, 112).

This system prioritizes immediate source identification and is efficient for research where the publication date is a key aspect of the argument or timeline.

If employing the author-date system, the concluding section is called a Reference List. Similar to a bibliography, it is alphabetized by author's last name. However, the primary distinction is that the Reference List includes only those sources that were cited in the text. The format for

entries in a Reference List is largely the same as for a bibliography, ensuring all necessary bibliographic details are present.
